1. At approximately 1310 hours, [redacted] Information Officer for the 913th Troop Carrier Group, was contacted by phone by a Mrs. [redacted] of [redacted] Ave., Strafford Station Apartments, Wayne, Penna. telephone [redacted]

2. [redacted] stated that both she and her husband observed a light hovering in the area over Wayne at approximately 2:50 a.m. 5 October 1965. Mrs. [redacted] described the light as extremely bright resembling a star that seemed to move constantly about the sky. At one time she stated the lights separated into two lights and some time later the two lights seemed to rejoin into one. She also stated that the light remained in the area for approximately an hour, and at one time during the period she saw a flash like lightning in the vicinity of the light. She stated that they heard a sound like a propeller driven aircraft, and that the object moved east of Wayne, Penna. and then headed slightly south and increased altitude. She stated that the night was very clear.

3. This office contacted the Navy Flight tower on this base and the Boeing Vertol PIO in Morton, Penna., as well as the Boeing Flight Test Section at Philadelphia International Airport, although with negative results.
