STOCKS OF LEAF TOBACCO OWNED BY DEALERS AND MANUFACTURERS

OCTOBER 1, 1939

Stocks of leaf tobacco owned by dealers and manufacturers in the United States and Puerto Rico on October 1, 1939, total 2,215,561,000 pounds compared with 2,227,029,000 pounds on October 1, 1938. Total stocks were 78,812,000 pounds higher than on July 1, 1939, and 11,468,000 pounds lower than on October 1, 1938.

Stocks of flue-cured tobacco were reported as 1,008,043,000 pounds on October 1, 1939, around 208 million pounds higher than on July 1, 1939, and only about 3 million pounds higher than on October 1, 1938. Stocks of Type 11 on October 1, 1939, were reported as 295,666,000 pounds; Type 12 as 310,421,000 pounds; Type 13 as 278,795,000 pounds; and Type 14 as 123,161,000 pounds. The flue-cured tobacco markets were closed from September 13 until October 10, 1939 due to the withdrawal of British buyers from the markets. As a result of this suspension of sales, stocks in the hands of dealers and manufacturers on October 1 were lower than normal considering the size of the crop.

Fire-cured stocks of tobacco of all types were reported as 127,802,000 pounds on October 1, 1939, compared with 158,040,000 pounds on October 1, 1938. Total stocks were about 20 million pounds lower on October 1, 1939, than on July 1, 1939. Virginia Fire-cured, Type 21, stocks were reported as 19,709,000 pounds; Type 22 as 80,816,000 pounds; Type 23 as 26,634,000 pounds; and Type 24 as 643,000 pounds.

Stocks of Burley were reported as 593,512,000 pounds on October 1, 1939, about 75 million pounds lower than on July 1, 1939, and around 28 million pounds higher than October 1 a year ago. Southern Maryland tobacco, Type 32, stocks were reported as 40,053,000 pounds compared with 39,966,000 pounds on October 1, 1938. These stocks during the period July 1, 1939, to October 1, 1939, increased around 10 million pounds.

One Sucker stocks on October 1, 1939, were 25,925,000 pounds or 4 million pounds less than the previous quarter of July 1, 1939. Green River stocks reported as 21,042,000 pounds were slightly higher than a year ago. Stocks of other types on October 1, 1939, were as follows: Virginia Sun-cured, 2,348,000 pounds; Eastern Ohio, 696,000 pounds; Perique, 909,000 pounds; Other Miscellaneous Domestic, 651,000 pounds; and Foreign-grown cigarette tobacco (Turkish and other), 92,655,000 pounds.

OCTOBER 1 CIGAR LEAF TOBACCO STOCKS

Stocks of American-grown cigar-filler types amounted to 171,142,000 pounds on October 1, 1939, a decrease of slightly over 15 million pounds from the stocks of October 1 a year ago. Type 41, Pennsylvania Seedleaf stocks, were reported as 90,970,000 pounds; Type 42, Gebhardt, 11,935,000 pounds; Type 43, Zimmer, 14,763,000 pounds; Type 44, Dutch, 9,805,000 pounds; Type 45, Georgia and Florida Sun-grown, 3,062,000 pounds; and Type 46, Puerto Rican, 24,137,000 pounds in Continental United States and 16,470,000 pounds on the Island.

The cigar-binder type stocks were around 20 million pounds lower on October 1, 1939, than they were October 1, 1938. Total binder type stocks were reported as 106,576,000 pounds. Type 51, Connecticut Broadleaf, stocks were 25,704,000 pounds; Type 52, Connecticut Havana Seed, 21,158,000 pounds; Type 53, New York and Pennsylvania Havana Seed, 2,463,000 pounds; Type 54, Southern Wisconsin, 31,135,000 pounds; and Type 55, Northern Wisconsin, 26,116,000 pounds.

Shade-grown wrapper type stocks were reported on October 1, 1939, as 11,643,000 pounds. Connecticut Shade stocks were 6,731,000 pounds, and Georgia and Florida Shade 4,912,000 pounds.

The Foreign-grown cigar leaf tobacco stocks in the United States on October 1, 1939 consisted of 6,620,000 pounds of Cuba (Havana) tobacco, 3,021,000 pounds of Java and Sumatra, and 2,913,000 pounds of Philippine Islands (Manila) tobacco.

The figures quoted for type totals are the sums of unstemmed and stemmed leaf as reported. A table is included showing American-grown types on a farm-sales weight basis with stemmed leaf converted to unstemmed equivalent, and also a table showing separately stocks owned by manufacturers and stocks owned by dealers. The detailed report shows all stocks subdivided according to groups recognized in the trade.

This report is now issued by the Agricultural Marketing Service to which the service and regulatory activities, formerly in the Bureau of Agricultural Economics, were transferred July 1, 1939 by authority in the Agricultural Appropriation Act.
