On 10/23/67 MEX-170 who has furnished reliable information in the past, advised that he had been notified on that date by the manager of the Cuernavaca Golf Club, that the person in whom he had previously been interested had returned to Cuernavaca.

Source went to Cuernavaca and contacted the manager and showed him photographs of the Subject. The manager confirmed the Subject had played golf on that course on Sunday, 10/22/67. Subject was using the name SCALZETTI, and was accompanied by Attorney JORGE CASTILLO of Mexico City.

Source is making the same information available through official channels to Mexican Immigration.

On 10/24/67 Attorney JORGE VASQUEZ ROBLES of the Mexican Immigration, advised that they anticipated sending Agents to Cuernavaca on 10/25/67 to check on this report.
