Lieutenant E. H. VOORHEES in a PB4Y-1P aircraft of Fleet Air Photographic Squadron ONE, took off from Agana Airfield, Guam, P. I. on 22 May 1945 at 0655 King to photograph enemy installations on Truk Islands. He arrived over the target at 1048 King and took good vertical photographs of Moen, Eten and Param airfields and of Dublon seaplane base all from an altitude of 18,000 ft. While crossing over Dublon Island, he encountered heavy, moderate, accurate anti-aircraft fire. One burst exploded near the starboard wing tip. Shrapnel from this burst hit the outer panel of the starboard wing entering the leading edge and emerging through the top of the wing. No other damage was sustained. There was no enemy interception. Lieut. VOORHEES returned to base at 1405 King.
