A newspaper article appearing in the June 26, 1968, issue of the "New York Times," captioned, "Cosa Nostra Men Cleared in Sicily," set forth information in part to the effect that among others, one Francesco Scimone, Boston, Massachusetts, was cleared in court at Palermo, Sicily, on June 25, 1968, of allegations of reportedly running narcotics and currency rackets for the Italian "Mafia" and the American Cosa Nostra's crime syndicates.

It is to be noted that indices of the Boston Office of the Federal Bureau of Investigation reflect that in 1965 the above-mentioned Francesco Scimone, a piano player and Manager of the Coral Gables Club, Weymouth, Massachusetts, was residing with the owner, Gary Sloisi, at 70 Colburn Street, Hull, Massachusetts.

Investigation determined Scimone apparently was wanted by the Italian police for allegedly associating with Italian hoodlums in Italy. It had been determined Scimone, on several occasions, while visiting Italy, reportedly had been observed in the presence of Lucky Luciano.

Scimone was employed at one time as an orchestra leader by both the Grace Lines, New York, New York, and had occasion to visit Italy many times. Also, Scimone, in the late 1950's and early 1960's, operated two night clubs in the area of Taoraina, Sicily, Italy, which were unsuccessful ventures and were finally taken over by his brother, Agisto.

LA COSA NOSTRA

The Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised in 1967 that the Judicial Tribunal of Rome had inquired if Scimone was ever considered a suspect in the attempted murder of Larry Gallo, a New York hoodlum, or if he had otherwise come to the attention of the New York Police authorities.

Investigation conducted by the New York Office of the Federal Bureau of Investigation in 1967 determined that Francesco Scimone, known to the New York City Police and involved in the attempted Larry Gallo murder, is not identical with the above-mentioned Scimone, the band leader and Manager of the Coral Gables Club, Weymouth, Massachusetts.

Scimone, in a previous interview, advised he had started civil action against 23 newspapers in Italy for "defamation of character," which action is being handled by his attorney in Italy and he also had legal representation in the United States relative to this matter.

It is requested that Legat, Rome furnish any and all pertinent information regarding Francesco Scimone and, in particular, if known, his present whereabouts in the United States.
