At the hours and place, taking advantage of a small family of the victim's, advancing on the eastern entrance, by the well, saying a single word 'Good evening' Matsuko, a daughter of the victim, 23 years old, opened the front shutter. At the same time one of them holding fast her shoulders under his arms forced her into the mosquito-net, while other three men out of four having invaded into the house, destroyed the electric lamp in kitchen and said, 'Give us money.' So grand mother raised a clamor. One of them held a revolver to her and threatened her that they would kill her if she should make a noise. They ordered to give suck <sup>to</sup> a child. They asked often to give them money quickly. We handed



about one thousand yen in cash over them which was put away in a clog case in the upper closet. With this they grumbled that how we, farmers, could get along with this a little bit of money and they began to search all over the house.

On that occasion, Taiji, the victim, the head of the family having finished his business and passed by the warehouse where one of the complicities was on looking out. Then the victim asked that what the matter was with him. He, in silence, held the victim's shoulders under his arms and accompanied him into a parlor where the man dealt the victim a few blows, having said 'Give us money, old man.' Then Taiji gave the burglar two thousand yen in cash which he carried with himself. They fled away with three thousand yen all together.

Upon they came in the vicinity of Chotoku Temple, Minecho, the man indicated a house and told her that the house was his and he would bring rice which was in the kitchen and he defrauded her of cash and a rucksack and fled away.
