AFFIDAVIT

UN.ICC-555

I hereby trustfully state the following facts of enemy atrocities which I personally witnessed:

On 5 March 1943, NAKAGAWA, Oichiro, Platoon Commander of the 65th Regiment, 104th Brigade, 13th Division of the Japanese Army, under the Command of SAKURAI, Tokutaro, who was stationed at Ju Ling Kuon, went to the home of YAO, Tsong Ju, at Yao Chiao Hung, the 5th Pao, Li Shih Shan, Kiang Ling District. He burned down YAO's house of 8 rooms, and robbed one cow from him.

The above statement contains facts free from falsehood. If the enemy atrocities stated above be eventually brought to trial in a court, I am willing to appear either as an accuser or as a witness and to undergo punishment for any malicious accusation or false testimony.
