

SUBJECT: Request for Authorization for Use of Burmese Puppet Embassy Building

- 1. The Problem. As a result of a request from the United Kingdom Reparations and Restitution Delegation, CPC/FP requested G-4 comments and recommendations regarding the use of the Burmese Puppet Embassy by the Burmese Diplomatic Mission.
- 2. References. a. C/N (1), CPC/FP to G-4, subject as above, 31 March 50.
 - b. Radio, W 84795, 22 August 1947.
- 3. Discussion of Facts. a. CPC/FP by reference 2a stated that the granting of permission to the Burmese Diplomatic Mission for use of the Burmese Puppet Embassy, 3-chome, Kita Shinagawa, Shinagawa-ku, Tokyo, is in accordance with paragraph 4d of reference 2b above, provided the property is not required for purposes of the occupation.
- b. The UKK&R Delegation has advised CPC/FP that a Burmese Diplomatic Mission will shortly be established in Tokyo and use of the subject property is desired.
- 4. Additional Data. Hq & Sv Gp (Capt. Newton) informed G-4 C&RE (Major Miller) that subject property is not on PD, nor is there any foreseeable occupation forces use therefor.
- 5. Conclusion. Reference 2b outlines current policy regarding use of real properties owned by puppet regimes by successive governments. Subject property is in the aforementioned category. There is no foreseeable occupation force use for this real estate.
- 6. Recommendation. Instant action informs CPC that there is no foredecable occupation force requirement for the Burmese Puppet Embassy. Accordingly G-4 interposes no objection to permitting the Burmese Diplomatic Mission to use subject real estate, in accordance with current policy.
 - 7. Action taken is within established policy.
 - 8. Action complete on G-4 Journal No. 3808.
