THE Regents of the Central and Primary schools having procured a healthy, commodious, and central position for the upper primary school have the pleasure of announcing to the public, that it is, this day, reopened under the care of Doctor J. A. Kimmurtz, principal, and J. Bignard assistant, in the Baptist Church, Lafayette square.
