the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell, and convey unto the said

*William Sutton a certain piece of woodland*

called "Baker's Island" containing one acre and one

quarter be the same more or less - situated in "Baker's

Marsh" so called in said Ipswich. Said Island

of woodland being the same that Richard Sutton

Esquire of Ipswich bought of William Brown of

Hamilton as by deed dated December 16<sup>th</sup> 1801 -

And recorded in Essex Registry of Deeds Book 109

Leaf 249

To have and to hold the granted premises, with all the privileges and appurtenances thereto belonging, to the said *William Sutton* and his heirs and assigns, to their own use and behoof forever.

And I do hereby, for myself and my heirs, executors and administrators, covenant with the said grantee and his heirs and assigns that I am lawfully seized in fee-simple of the granted premises, that they are free from all incumbrances

that I have good right to sell and convey the same as aforesaid; and that I will and my heirs, executors, and administrators shall warrant and defend the same to the said grantee and his heirs and assigns forever against the lawful claims and demands of all persons.

And for the consideration aforesaid

do hereby release unto the grantee and his heirs and assigns all right of or to both dozer and homestead in the granted premises.
