MEMORANDUM FOR: JAPANESE GOVERNMENT

SUBJECT: Customs, Immigration and Quarantine Operations

2. Effective this date and in accordance with directives promulgated by the Supreme Commander for the Allied Powers, the Japanese Government is responsible for customs, immigration and quarantine operations attendant to the entry into and exit from Japan of individuals, cargo, surface vessels and aircraft, except for occupation force personnel, cargo, surface vessels and aircraft entering or leaving Japan.

3. Designated agencies of the Supreme Commander for the Allied Powers will regulate, by surveillance over the operating agencies of the Japanese Government, the implementation of the provisions of paragraph 2 above.

4. The Japanese Government is directed to review existing procedures pertaining to customs, immigration and quarantine and to take such actions as may be necessary to establish effective customs, immigration and quarantine controls in agreement with generally accepted international practice. These actions will be coordinated with the appropriate agencies of the Supreme Commander for the Allied Powers.

5. Direct communication between the Japanese Government agencies concerned and appropriate agencies of the Supreme Commander for the Allied Powers is hereby authorized to further the implementation of this memorandum.

6. The provisions of all earlier memoranda for the Japanese Government pertaining to customs, immigration and quarantine operations in conflict with the instructions contained herein are superseded by this memorandum.
