NEW ALLOTMENTS

August 6, 1937

GEORGIA 8068 Grady

Grady County Electrical Association
Cairo, Georgia

Partial allotment of \$75,000 out of a total of \$171,000 requested to build 187 miles of line to serve 597 customers in Grady, Mitchell and Decatur Counties. Wholesale power will be supplied by the Haywood municipal plant.

GEORGIA 8069 Washington

Washington County Rural Electrification Association
Sandersville, Georgia

Allotment of \$76,000 to build 78 miles of line to serve 290 customers in Washington County. Wholesale power will be supplied by the Georgia Power Company.

GEORGIA 8074 Jefferson

Jefferson County Rural Electric Assn.
Louisville, Georgia

Partial allotment of \$75,000 out of a total of \$184,000 requested to build 186 miles of line to serve 1,069 customers in Washington, Jefferson and Glascock Counties. Wholesale power will be supplied by the Georgia Power Company.

MINNESOTA 8068 Carver

Carver County Cooperative Electric Assn.
Waconia, Minnesota

Partial allotment of \$100,000 out of a total of \$152,000 requested to build 143 miles of line to serve 477 customers in Carver, Sibley and Hennepin Counties. The source of power has not yet been determined.

NEBRASKA 8024B Lancaster

Lancaster County Rural Public Power District,
Lincoln, Nebraska

Partial allotment of \$150,000 out of a total of \$307,000 requested to build 279 miles of line to serve 680 customers in Lancaster, Sanders, Cass and Otoe Counties. Power will be supplied by the Iowa-Nebraska Light & Power Co., pending completion of generating facilities of the Loup River Public Power District. Previous allotments to the sponsors total \$396,000 for distribution lines and \$5,950 for wiring and plumbing installations. These lines are now under construction.

NEBRASKA 25 Saline

Norris Rural Public Power District
Crete, Nebraska

Partial allotment of \$150,000 out of a total of \$322,000 requested to build 291.5 miles of line to serve 726 customers in Saline and Jefferson Counties. Power may be supplied by the municipal plants at Crete and Fairbury pending completion of the generating facilities of the Loup River Public Power District.

NEBRASKA 8054 Cuming

Cuming County Rural Public Power District
West Point, Nebraska

Partial allotment of \$250,000 out of a total of \$450,000 requested to build 401 miles of line to serve 1,045 customers in Cuming, Stanton, Wayne, Dodge and Thurston Counties. Power may be supplied by the West Point municipal plant pending completion of the generating facilities of the Loup River Public Power District.

OREGON 8015 Multnomah

Portland General Electric Company
Portland, Oregon

Allotment of \$100,000 to this company to build extensions to their lines in Multnomah, Columbia, Washington, Yamhill, Marion and Clackamas Counties. The extensions will total 109 miles of line and serve 573 customers.

WYOMING 8006C Goshen

Wyrulec Company
Lingle, Wyoming

An additional allotment of \$156,000 to build 150 miles of line to serve 392 customers in Goshen County. Power will be supplied by the U. S. Bureau of Reclamation. Previous allotments to this company total \$62,000 to build 54 miles of line to serve 163 customers.
