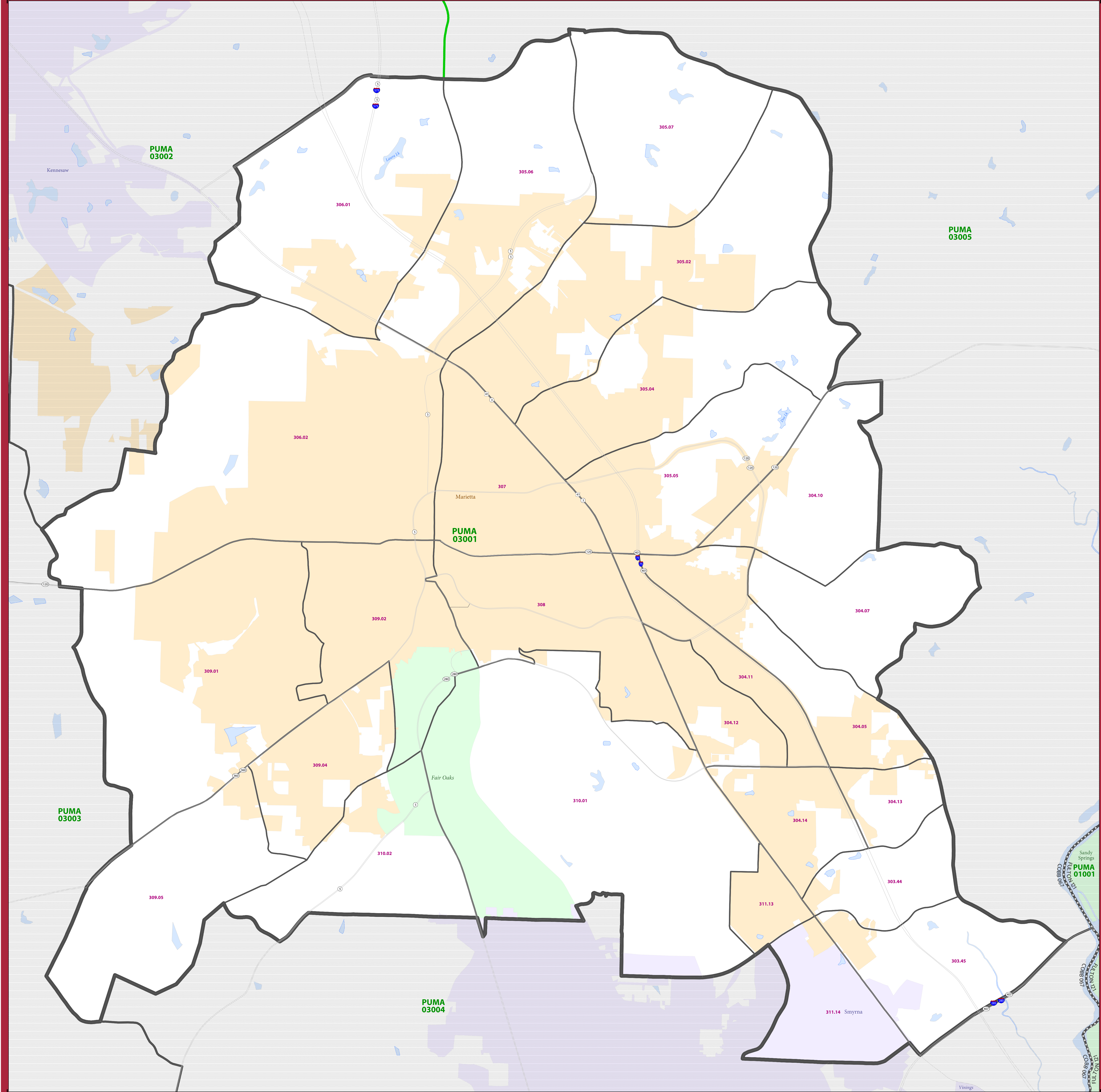


2010 CENSUS - PUMA REFERENCE MAP: Atlanta Regional Commission (Northwest)--Cobb County (Central)--Marietta City
