Whereas:

- (1) On 17 March 2014, the Council adopted Regulation (EU) No 269/2014.
- On the basis of a review by the Council, the information concerning certain persons and entities in Annex I to Regulation (EU) No 269/2014 should be amended.
- (3) Annex I to Regulation (EU) No 269/2014 should therefore be amended accordingly,
