ADMINISTRATIVE (CONT'D)

Departmental Attorney THOMAS B. DE WOLF was in the NYO on 9/25/58, to discuss another matter regarding Cuban revolutionary activity in the United States. During this conversation with Mr. DE WOLF, it was ascertained that at the present time, PRIO and his attorneys have an appeal before the Supreme Court to change venue from NY to Miami, Florida. Mr. DE WOLF expressed a private opinion to the effect that he saw no reason why PRIO could not have venue changed to Miami, and stated that it is the opinion in the Department that if venue is changed to Miami, the government will lose its case against PRIO for violation of Title 18, US Code, Section 960.
