SUMMARY OF RELEVANT POINTS

3350-A - Excerpts from book, "Our Enemy Japan" by Wilfrid Fleisher (1943)

Excerpts (pp 48-49; 50-51) contain author's explanation of the negotiations leading up to the Anti-Comintern Pact and a statement regarding its unpopularity in Japan.

SHIRATORI, Toshio is quoted as stating to the author that the pact had been worded vaguely on purpose so that "it might serve as a frame for any kind of picture which might later be drawn in". SHIRATORI is also quoted as saying that his role in the negotiations had been that of "a second-line Chinese soldier", i.e., to encourage the front-line negotiators.


