The Boreau will note that recent acts of violence and threats attributed to PC are really acts of ORLANDO BOSCH AVILA and his organization, MIRR, using the name PODER CUBANO. Miami Office is conducting an intensive investigation of the MIRR concerning these reported acts of violence.

Concerning the Cuban Nationalist Movement (CNM), U. S. Customs reports that the PEREZ-GARCIA faction is inactive. MM 635-S maintains daily contact with the FELIPE RIVERO group of the CNM, and advised that RIVERO and his associates are inactive and have no plans for the immediate future.

It is noted a New York informant recently visited Miami and talked with JULIO PEREZ, who stated he is no longer in the CNM. This informant also talked with RIVERO, and reported RIVERO's group is inactive.
