REGULATIONS

National Public Safety Commission Regulations No. 3

July 19, 1948

A part of the Regulations of the Establishment of the Office of the Imperial Guard (Regulations of the National Public Safety Commission No. 2, 1948) shall be amended as follows:

National Public Safety Commission In Art. 1, "Kyujo" shall read "Kokyo."

Supplementary Provision:

The present Regulations shall be applicable as from July 1, 1948.


