[redacted] ERIC WRIGHT, rap singer and former owner of RUTHLESS RECORDS. [redacted] was responding to a business card left by Deputy [redacted] LOS ANGELES SHERIFF'S DEPARTMENT, which had been placed in the mail box of her client at [redacted] California.

[redacted] provided the following brief synopsis of the history of RUTHLESS RECORDS and [redacted] to assist the interviewing agent:

Over the years, various local rap singers had signed contracts with WRIGHT's record label, RUTHLESS RECORDS. They eventually began to believe that JERRY HELLER, WRIGHT's manager, was dishonest with them financially, and so HELLER became a sore point in the company. In the Spring of 1991, some of the rap artists wanted to be released from the RUTHLESS RECORDS label contract because they were becoming successful on their own. WRIGHT refused to cancel the contracts and thereafter began to receive death threats. At one point, WRIGHT was visited by [redacted] et al, who were armed with bats and lead pipes threatening WRIGHT to cancel the contracts. HELLER was also allegedly visited and threatened in a like manner, with a gun held to his head. There were no witnesses to the visit to HELLER.

In 1992, as a result of the death threats, WRIGHT hired [redacted] for [redacted] a position he kept until WRIGHT's death. Payments to [redacted] i.e. 1099's, are represented in the bookkeeping records of RUTHLESS RECORDS. [redacted] impressed WRIGHT that he (WRIGHT) was indispensable [redacted] In addition, HELLER, who has known [redacted] for years, [redacted] WRIGHT and HELLER had a falling out in the Fall of 1994 and [redacted] WRIGHT eventually did cancel the contracts as a result of the death threats.

[Redacted] The lawsuit did not go to trial as it was settled out of court. The results of the lawsuit were classified by the court as "confidential" and would require a subpoena.

During the lawsuit, the court ordered the offices of RUTHLESS RECORDS to be closed, which, at the time was on file with the INTERNAL REVENUE SERVICE as an F Corporation with taxes paid up to date. CHEMICAL TRUST COMPANY OF CALIFORNIA (CTC) was appointed by the court as the Corporation Special Administrator.

On July 7, 1995, [redacted] Financial Services for RUTHLESS RECORDS, 21860 Burbank Boulevard, Suite 100, Woodland Hills, California, telephone [redacted] was advised of the identity of the interviewing agent and the purpose of the interview and provided the following information.

[redacted] was interviewed regarding his knowledge of possible stolen master recordings which are the property of RUTHLESS RECORDS. [redacted] joined RUTHLESS in [redacted]. He stated that RUTHLESS RECORDS is also known as COMPTOWN RECORDS. It is privately owned by ERIC WRIGHT, aka "EAZY E". RUTHLESS has an agreement with RELATIVITY RECORDS for RELATIVITY to do the manufacturing and distribution of recordings produced by RUTHLESS artists.

He stated that starting in late February, WRIGHT became seriously ill and was hospitalized due to complications from AIDS. Information about WRIGHT's hospitalization was kept quiet and no one at RUTHLESS knew of the illness.

About the time when WRIGHT entered the hospital, a woman named [redacted] and an attorney named [redacted] "came into the picture". [redacted] On February 20, 1995, [redacted] received a facsimile allegedly from WRIGHT which [redacted] WRIGHT. [redacted] provided a copy of this document to the interviewing agent. [redacted]

[redacted] then requested financial information regarding the company but [redacted] said he would not release the information without WRIGHT's approval. [redacted] picked up the telephone and dialed a number and [redacted] spoke to WRIGHT who authorized the release of information. A few days before WRIGHT's death, WRIGHT and [redacted] were married at the hospital and WRIGHT changed his will making [redacted] and [redacted] the executors of the estate.

[REDACTED] stated that he was not familiar with any business arrangements between WRIGHT and [REDACTED] does not know what title [REDACTED] carries but stated that [REDACTED] came into the office a few days a week [REDACTED] Prior to WRIGHT's illness, WRIGHT only came into the office now and then.

WRIGHT's original business partner was JERRY HELLER. HELLER was the General Manager. HELLER and WRIGHT had a falling out and HELLER was fired in February. HELLER and WRIGHT started RUTHLESS. After HELLER was terminated, [REDACTED]

On March 17, 1995, just prior to WRIGHT's death, [REDACTED] secured the offices of RUTHLESS. Three days later, [REDACTED] and [REDACTED] had changed the locks on the doors at RUTHLESS and would not allow any employees to enter including [REDACTED] and [REDACTED] was advised by [REDACTED] to "go home and sit tight". About one week later, the Court secured the offices and [REDACTED] and [REDACTED] were also denied access.

[REDACTED] was contacted several weeks later by CHEMICAL BANK and asked to return to RUTHLESS at noon on April 27, 1995. [REDACTED] was the only person authorized to enter the office. The Trustee from CHEMICAL advised [REDACTED] that he was not to make business decisions and that everything had to go to the Trustee but that he was to keep the company running.

During the next few weeks, [REDACTED] remembered leaving the office on a Friday and the message on the answering machine was the usual message. While sitting in the office the following Monday, [REDACTED] was screening calls because he could not handle the amount of in-coming calls by himself. During one call-in, he noticed that when the answering machine picked up, the

message on the machine had been changed and [REDACTED] changed it back. He stated that he doesn't remember the exact message but that it gave a new phone number for RUTHLESS in Canada.

He advised that although he was the only person with physical access to the office, the message can be changed by remote telephone access. He denied changing the message himself. He only remembers that the voice on the new message was that of a male and stated that he really didn't pay attention to the message and just changed it back.

He believes that on one occasion, [REDACTED] from CHEMICAL TRUST was at RUTHLESS when a man named [REDACTED] called. He stated that he had a deal with RUTHLESS. [REDACTED] said he knew nothing about it and didn't have time to deal with this and terminated the call.

He knows that there have been lots of discussions about the possibility of missing master recordings but he has no information about it. He stated that [REDACTED] is now running RUTHLESS and was appointed by the Court. He stated that he has not heard of any bootlegging of WRIGHT's recordings.

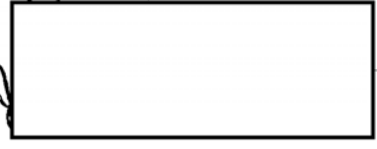

[redacted] believes that even WRIGHT didn't know he had stocks. The company was run more like a partnership than a corporation. [redacted] doesn't believe any stocks have been issued. [redacted]

Since WRIGHT's death [redacted] has not been allowed to enter RR.

He stated that he received a telephone call from the Special Administrator, [redacted] who told him that a man in [redacted]
