

Boston 27th Novemr 1854

My dear Sir

You have doubtless been expecting to hear from me several days past, but that piece of delinquency Vose did not pay his Rent until yesterday, tho' after call'd on. He is a most troublesome Shop! - Mr. Merrill immediately made up his A/c, a copy of which is enclosed & the result is, having had 2 years tax to pay & \$15.14 repairs, a balance is due to A/c of \$1.73. Fortunately there will be no tax to pay out of the next 3 yrs acc'ts & I hope no heavy repairs. - I long for the time to come when we can bring this tedious business to a close.

On my return from Brattleboro' a few weeks since I met a parishioner of yours Mr. Phelps I believe with his wife at Greenfield on their way to Salem, my only regret was that they did not make themselves known until they were just stepping into the Stage to be off.

I had been to Brattleboro' to see my daughter Abby who is there under treatment of Dr. Wesselhooff at the "water cure" for w^{ch} she thinks she is deriving benefit. - She has now had 9 weeks trial of it & has been most faithfully attentive to every prescription. excuse the great haste in w^{ch} I write on love to Beloit & children. truly thy Servant
