SUBJECT: Proposed Establishment of Mexican Diplomatic Mission in Japan

- 1. By C/N to the C/S thru G-1, G-2, and G-4, subject as above, 31 December 1949, the Diplomatic Section requests approval of draft note to the Swedish Mission.

- 1. Inclosed herewith for approval is DS draft note (Tab A) in reply to the Swedish Diplomatic Mission's note of 22 Dec 49 (Tab B), which reports that the Mexican Covernment requests through its rapresentative in Japan to be advised whether a Mexican career-official would be acceptable for accreditation to the Supreme Commander as the Mexican Diplomatic Representative in Japan.
- 2. Present DS draft note (Tab A) informs the Swedish Diplomatic Mission that the Supreme Commander would welcome the appointment of a representative of the Mexican Government. It requests that the name and other particulars concerning the representative and his staff be forwarded when available in order that arrangements may be made for entry into Japan.
