Having been employed for some time in the commencement of 1856, in connection with Mr. Sommers, in constructing a map of the district of Chontales, for the Government of the Republic, then under the Presidency of Patricio Rivas, the writer is enabled to give some particulars of that section of country, which are undoubtedly interesting to your readers.

The district of Chontales is situated between Lake Nicaragua on the West, the Cordilleras on the East, the San Juan River on the South, and extends about 150 miles towards the north. The Cordilleras here are on their western slope, a similar character as the Sierra Nevada of California. The main chains are rugged, and the spurs and foothills, which have a rounded form, extend towards the lake, covering a large surface. The geological formation of the interior of the Republic of Nicaragua is, indeed, very similar to that of the interior of California.
