3. During my tour of duty it was customary for the military attaché to handle directly all matters strictly military, without conference with the Ambassador. However, after agreements went beyond the preliminary negotiation stage they were then handled by the Ambassador. Matters which concerned the diplomatic negotiations not strictly military were the subject of conference with the Ambassador. However, the Military Attaché always retained the position independently of the Ambassador and was accountable to the military authorities in Tokyo. I have no reason to believe that the system in Germany was any different from London and other Japanese embassies throughout the world.
