## **ORDINANCE NO. 2022-17**

AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF THE FOLLOWING STREETS IN THE CITY OF ALAMINOS, PANGASINAN TO WIT:

- 1. PORTION OF C.P. GARCIA STREET (BETWEEN PLAZA MARCELO OCHAVE AND ALAMINOS CITY HALL BUILDING) AND PORTION OF QUINTOS STREET (FROM INTERSECTION OF QUEZON AVENUE AND C.P. GARCIA STREET TO INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET AND FROM INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET TO INTERSECTION OF QUINTOS STREET AND SAN JOSE DRIVE) FROM NOVEMBER 21, 2022 TO JANUARY 9, 2023 FOR THE ESTABLISHMENT OF CHRISTMAS BAZAAR; AND
- 2. PORTION OF RABAGO STREET FROM NOVEMBER 21, 2022 TO JANUARY 9, 2023 TO SERVE AS TEMPORARY PARKING AREA
