REGARDING FOREIGN TRAVEL OF SUBJECT AND METHODS OF ENTERING AND LEAVING MEXICO, PRIVATE AIRCRAFT MAY HAVE BEEN USED AT LEAST ON SOME OCCASIONS. MEXICO CITY LETTER APRIL 24, 1970, REPORTED THE ARRIVAL AND DEPARTURE ON FEBRUARY 11, 1970, AT THE MEXICO CITY INTERNATIONAL AIRPORT OF A LEAR JET, REGISTRATION N551 (MD), WITH LISTED OWNER AS TIGER OIL COMPANY. *SCU*

IMMIGRATION RECORDS SHOWED THIS AIRCRAFT ARRIVED WITH TWO PILOTS AND NO PASSENGERS BUT DEPARTED WITH PHYLLIS MC GUIRE LISTED AS THE ONLY PASSENGER. MISS MC GUIRE HAD EXPLAINED TO LAS VEGAS AGENTS THAT SHE SPENT SEVERAL DAYS WITH SUBJECT IN ACAPULCO AND CUERNAVACA, MEXICO, AND REQUESTED THAT EDWARD MIKE DAVIS SEND A JET TO PICK HER UP IN MEXICO AFTER SUBJECT PHYSICALLY ABUSED HER. LAS VEGAS LETTER MARCH 30, 1970, INSTRUCTS
