GENERAL HEADQUARTERS FAR EAST COMMAND APO 500 AG 315 (13 Apr 51) AG 13 April 1951 Eupply of Bureau of Internal Revenue Forms TO: Commanding General, Headquarters and Service Command, General Headquarters, Far East Command, APO 500 1. Letter, General Headquarters, Far East Command, AG 315 (4 Aug 49) AG-OP, subject as above, 4 August 1949, is rescinded.

- 2. The Commanding Officer, Far East Command Printing and Publications Center, APO 503, will requisition from the Commanding Officer, Overseas Supply Division, San Francisco Port of Embarkation, and stock Bureau of Internal Revenue Forms required by personnel of United States Army, Nevy, and Air Force activities of the Far East Command to prepare and render income tax estimates and returns, except the specialty-type Withholding Statement (TD Form W-2). This will include federal income tax forms used by disbursing officers, military organizations, non-appropriated fund activities such as clubs, billets and theaters, as well as for individual taxpayers.
- 3. Army disbursing officers will procure the specialty-type Withholding Statement, for year-end reports only, in accordance with Circular 16, Department of the Army, 1951. TD Form W-2 (out sheet) will be stocked and issued by the Commanding Officer, Far East Command Printing and Publications Center, for interim use only.
- 4. Commanding Officers of United States Army activities will submit requisitions for such Bureau of Internal Revenue Forms to appropriate Publications Supply Points or Units, and Commanders of Naval and Air Force activities will requisition through their normal publications supply channels.
- 5. It is desired that the Commander, Naval Forces, Far East, and Commanding General, Far East Air Forces, submit their requirements to the Commanding Officer, Far East Command Printing and Publications Center, APO 503, not later than 1 September of each year preceding that in which the forms are to be used.
