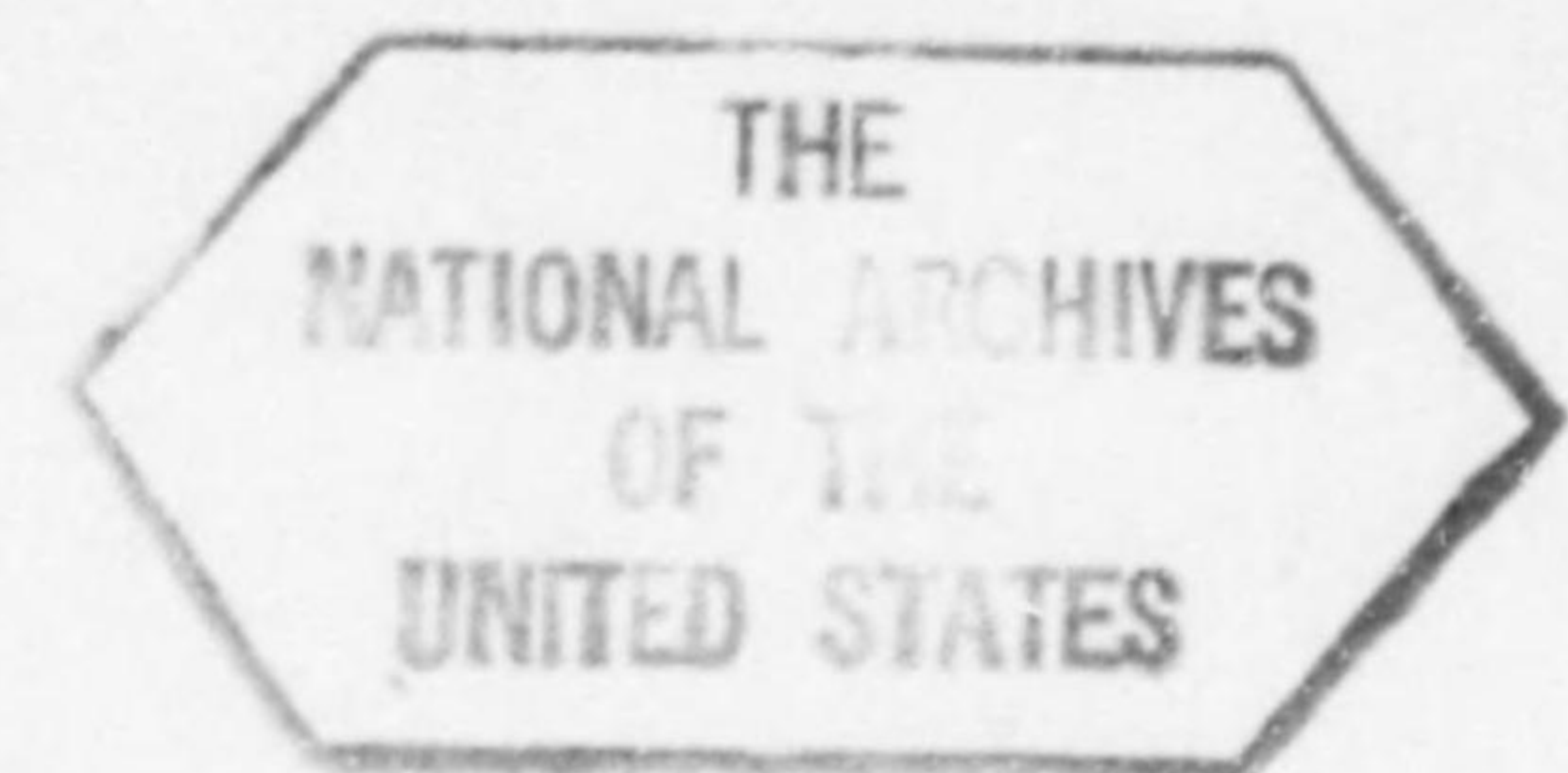

The above-mentioned person inflamed workers of Harima Ship building Yard by distributing leaflets in front of Kure Station, Kure City, 1 July 1950, to the effect that the Korean event is <sup>an emancipation eliminating</sup> a war for emancipating the reactionalists in Japan who are figureheads of foreign imperialism, that the intervention of the U N and the supply of arms by foreign powers will mean to trample down the will of all Korean people, by secretly carrying out a plan of rationalizing the establishment of military bases in Japan, and that the last-named plan should be crushed, the intervention of the U N. and the U.S.A. with Korean problems should be checked and the manufacture and transportation of arms should be immediately stopped. Such action as above described cannot but be interpreted as publishing his attitude antagonistic to the aims and policies of the Occupation Forces.

Accordingly the decision has been made that the person in question shall be unacceptable under the regulation of Joint Ministerial Order No. 1, Annexed Table ~~No. 1, Ar.~~ I Par. (3).

Decision

1. Name: Kurataro Nishioka
2. Address: 1638 Aichi-machi, Higashi Matsuura-gun, Saga Pref.
3. Qualification: Candidate for membership of Saga Pref. Board of Education

The above-mentioned person made a speech on the street in front of Chikamatsu Theatre, Asahi-machi, Karatsu City, 1 June 1950, and another speech in the Citizen's Hall, Karatsu City, 9 June 1950, both to the effect that major portion of the taxes we pay are expended for the purpose of establishing military bases or such like things, and the counterpart funds created by importing surplus food from America for nothing and by delivering it to the people with charge are being circulated with priority among munition factories, with the result that Japan is now on the highway of enslaving herself to a specific foreign power.

Such action taken by the above-mentioned person cannot but be interpreted as publishing his attitude antagonistic to the aims and policies of the Occupation Forces.

Accordingly the decision has been made that the person in question shall be unacceptable under the regulation of Joint Ministerial Order <sup>No 1,</sup> Annexed Table ~~No. 1, Ar.~~ I, Par. (3).

Decision

1. Name: Shonosuke Suenaga
2. Address: 850-2 Senriyama, Suita City, Osaka Pref.
3. Qualification: candidate for member of Osaka Pref. Board of Education.

The above-mentioned was employed in April 1939 in Tokyo office of Asahi Shimbun, transferred to Osaka main office of the same agent in August 1942, where he remained until 28 July 1950, when he was expelled on the basis of Article 45 Par. 6 of the Service Regulation of the Asahi Shimbun. Between 16 Dec. 1948 and 25 8 1950, he was in charge of publishing the "Morning Glow" a cell organ of Osaka Asahi Shimbun, whose publication was prohibited on 25 Aug. 1950 as paper akin to the "Akahata", on the basis of General MacArthur's letter to Premier Yoshida.

Such action taken by the above-mentioned person cannot but be commented as publishing his attitude antagonistic to the aims and policies of the Allied Forces now occupying Japan.

Accordingly the decision has been made that the person in question shall be unacceptable on the basis of the regulation of Joint Ministerial Order No 1, Annexed Table ~~No. 1, Art. I~~, Par. (3).
