SUBJECT: Audio-Visual Program for National Police Reserve

1. It is desired to make CIE 16 mm films and suitable Japanese pictures available to members of National Police Reserves in the Tohoku Region as a medium of Reorientation.

2. There are five camps in Miyagi which have approximately 13,000 reservists and one camp each in Aomori and Yamagata Prefectures which together have another 3,000 men.

3. The lack of projectors and screens to make loans of equipment to each camp is hindering this project.

4. Present demands for projectors received by the A-v Librarians excludes the furnishing of this equipment at prefectoral levels.

5. This information is submitted to justify request herewith for seven more sets of equipment, one set to be placed in each of the seven camps, thus eliminating costs of transportation except for that of films.

6. If not inconsistent with current plans, it is recommended that this matter be considered by the Civil Information officer in effort to furnish above equipment.

MEMORANDUM FOR RECORD:

14 November 1950

1. Chief, Tohoku Region was instructed this date to increase the strength of Camp Funacka from its present strength of 846 to a strength of 1,050, the authorized capacity of this camp. He was further instructed to locate and mark for possible shipment to Camp Haugen 400 enlistees whose homes are in Northern Honshu. He was advised that in the event it was decided to make the shipment to Camp Haugen, instructions would be issued from this section.

2. Chief, Tohoku Region stated that accommodations are available now for 204 additional enlistees at Camp Funacka and for 400 additional enlistees at Camp Haugen.

3. Logistics advises that no supply or transportation difficulties would be caused by the movements mentioned in paragraph 1.



SUBJECT: Organization and Initial Training of National Police Reserve Enlistees

TO: Chief, Tohoku Civil Affairs Region

1. Reference, "Basic Training Program for National Police Reserve Recruits."
2. You will take the necessary action without delay to organize National Police Reserve enlistees in camps in your area into units shown on attached station list, incomplete, inclosure 1. You will be advised of additional units to be organized at stations in your area in the near future. For the present, organizations will extend only through company level. Companies and smaller units will be designated in accordance with the troop list attached, inclosure 2. Instructions as to the organization of battalions and higher units will be issued later. A complete set of tables of organization for units of a division is attached, inclosure 3. Tables of organization will not be released to the Japanese. Tables of organization have not been completed for service command units. Until these tables of organization can be furnished, organization of service command units will be limited to forming of companies or detachments of the strength indicated on the station list. For purposes of accomplishing basic training small units may be attached to companies. They will retain their designation.
3. Inclosure 2 may be given to the Japanese. The following table provides necessary additional information for your use in effecting unit organization:

4. Effective upon the date of the organization of each company or other organization you will designate personnel to act as officers and non-commissioned officers in each unit. Such verbal appointments will be in an acting capacity only. National Police Reserve personnel appointed to grades and ranks in an acting capacity will not wear the insignia of rank or grade to which appointed nor draw the pay of the rank or grade. Company or unit rosters containing the name, serial number, acting rank or grade of all personnel will be forwarded to this headquarters, attention Chief of the Personnel Division, Civil Affairs Section Annex, with the least practicable delay.

5. A supply of "Unit Progress Chart," Form 100, for use by each company or unit, is being forwarded under separate cover. These charts will be used in preparing the weekly report on the status of training. Copy of this chart with English translation is attached as inclosure 4.

2. Graduates of a school established at this headquarters for the purpose of training personnel officers have been assigned to your area. It is desired that a school for company administrative personnel - first sergeants and company clerks - be established at each camp. Graduates referred to above will be used as instructors.

3. It is desired that the school begin on 25 September and continue for a period of two weeks. The course will be repeated until all companies or similar units have been provided with a trained and well qualified first sergeant and company clerk.

SUBJECT: Telephone Conversation with Col Toole, Tohoku Area

1. Col Toole called this date to ask a number of questions in connection with Japanese National Police Reserve. Questions and answers given follow:

Question: General Piburn has asked us for strength reports. Should we give them to him?

Answer: Yes.

Q. There is much activity on the part of Air Force at Matsushima. They don't know about our planning to use the barracks space there. Are we still planning to use it?

A. Yes. We have been given the understanding verbally that we may use that. Written confirmation is expected today.

Q. It looks as if all mess equipment at Matsushima will be required by Air Force. Can we count on using any of it?

A. I will pass this question to Logistics and ask them to give you an answer on procedure there.

Q. We have noticed that at drill the Japanese use different movements than ours. Col Kowalski advised that we would train according to American procedures. Does this apply to riot formations also?

A. Yes. We are having extracts from field manuals translated. As fast as we can get them printed they will be sent to you.

Q. Will there be any transfer of Rural Police personnel to the Reserve?

A. No.

Q. Our public health people here have received some material from Col Schellenberger as to elementary camp sanitation, health procedures and the like. Since our health people hadn't been brought in on this I wondered how far I could go in acquainting them with the plan.

A. I know that General Shepard has directed Col Schellenberger to give assistance in this phase of the program. To what extent he has been directed to communicate with public health personnel on the teams I do not know. However, to answer your question, you may take these people into so much of the plan as may be necessary to permit them to carry out the directions as to health, sanitation, and medical care given them by Col Schellenberger.

2. Col Toole, having no more questions, was then advised that the plan for shipping enlistees had been changed and that instead of previously announced shipments, he would receive enlistees as follows:

Schimmelpfennig.....1600 from 30 Aug Increment
Haugen.....1800 from 9 Sep Increment
