MILITARY PROCUREMENT—AIR FORCE

Levi, who represented the American Council on Education; John H. Arrington, Office of Assistant Secretary of Defense (Properties and Installations); Curtis E. Huber, National Association of Real Estate Boards; Arthur J. Packard, American Hotel Association; and R. Manning Brown, Jr., who represented the American Life Convention and Life Insurance Association of America, and who was accompanied by his associates.

TAXATION

Committee on Finance: Committee, in executive session, ordered favorably reported with an amendment H.R.

D235

5189, to exempt from tax income derived by a foreign central bank of issue from obligations of the U.S. (amendment would add text of S. 1391, relating to the election of certain business corporations not to be taxed as corporations in a community property State).

The committee also considered, but did not conclude action on, H.R. 4884, authorizing Federal financial participation in aid to dependent children of unemployed parents. Committee will meet again tomorrow for the further consideration of this bill.

Miller, West Virginia Horticulture Society; Rev. James L. Vizzard, S.J., National Catholic Rural Life Conference: Rev. Galen R. Weaver, United Church of Christ, and National Council of the Churches of Christ; Mildred Fairchild Woodbury, chairman, National Child Labor Committee; Mrs. Elizabeth Coleman, National Consumers League; and Mrs. Mary Condon Gereau, National Education Association.
