Lieutenant R. W. KOBLE in a PB4Y-1P aircraft of Fleet Air Photographic Squadron ONE took off from Agaña Airfield, Guam, M. I. on 1 June 1945 at 1022 King to photograph enemy installations on Truk Islands. He arrived over the target at 1415 King and took vertical photographs of Eten airfield and Dublon seaplane base from 17,800 ft., of both Moen airfields from 16,800 ft., and from 16,000 ft., and of Param airfield from 15,000 ft. Heavy-moderate accurate antiaircraft fire was encountered coming from Dublon Island. Medium antiaircraft fire was encountered over Param Island. There was no enemy interception. Lieut. KOBLE returned to base at 1735 King.
