Per instructions in referenced Bureau airtel, Philadelphia has reviewed its letterhead memorandum (LHM) submitted as an enclosure to referenced Philadelphia airtel dated 2/19/64, and inasmuch as referenced LHM does not contain any information furnished by PH T-1, which disclosure would have an adverse effect on the national defense interests of the country, Philadelphia is declassifying its LHM. Therefore, the Bureau and other recipient offices are requested to likewise declassify their copies of referenced Philadelphia LHM.

As noted in referenced Bureau airtel, Philadelphia requested recipient offices to furnish Philadelphia information concerning [REDACTED], his background, and information bearing on his capabilities of being directed as an informant in the racial field. This request was included in Philadelphia airtel concerning the "Minute Men" in the interest of simplicity and in order to preclude the necessity of preparation of separate communication containing essentially the same information and submitted under the 170 classification which would have necessitated a duplication of effort. It is noted a copy of referenced Philadelphia airtel was designated to Philadelphia 170-New on [REDACTED].
