The operations of the CIA station [redacted] received a crippling blow in September, 1960, when Cuban G-2 authorities discovered that [redacted] had established a technical surveillance on the Overseas China News Agency which had offices located in the [redacted]

[redacted] evidently became aware of this CIA operation due to the fact that various CIA operatives, who were noticeably North Americans, were frequenting an apartment [redacted]. In the general round-up, [redacted] two U. S. Embassy employees, one being Mrs. MARJORIE A. LENNOX, an employee of the Commercial Section, and [redacted], who was listed as a Third Secretary at the U. S. Embassy [redacted]. Also arrested were four undercover operatives of CIA who are North Americans. The [redacted] Government was also able to confiscate much technical equipment which was used in this technical surveillance. Photographs of the technical equipment were published in the [redacted] newspaper, [redacted] and consisted of numerous tape recorders, and other monitoring equipment.

In connection with this operation, various other CIA operatives [redacted] were compromised. Included among these were the following who were assigned as officers at [redacted] and another female employee of the U. S. Embassy who was secretary to the Administrative Officer and Security Advisor, [redacted]. It appears that actually she was the one who was working in an undercover capacity for CIA and not MARJORIE A. LENNOX who was the one arrested by [redacted].

From conversations with CIA representatives, it appeared that the agents were compromised because they were seen to be in direct contact with the undercover operatives whom CIA had placed [redacted]. The CIA agents assigned to [redacted] evidently mixed socially with the CIA undercover operatives and in this manner became known to [redacted].

Another <sup>U.S.A.</sup> CIA representative, [redacted], has also been recalled to the United States as it has been feared that his contact with [redacted] might be known [redacted].

With respect to the four operatives who were undercover and who are presently being detained [redacted] these individuals have not been seen by any representatives of the U. S. Embassy for the past month. The [redacted] Government has given no indication as to what penalty they might suffer. CIA station Chief, [redacted] has expressed his concern to the Legat, [redacted], concerning the possible action which the [redacted] Government might take against these individuals. One source informed Legat he was informed by [redacted] representative that the [redacted] Government might ask for the death penalty for these four, but that if such penalty is decreed, it would be reduced to a jail term of 30 years.

The present set-up of the CIA station [redacted] is as follows:
