On 18 October 1955, the records of CIC-CF, Fort Holabird, Maryland, were searched in the name of the Subject and the following information was revealed:

Dachau Detachment, War Crimes Group, JA Division, United States Forces, Europe Security Section, Army Post Office 205, Document, dated 24 September 1945, Subject: Identification of Prisoners, reveals the name of Matthias \_\_\_\_\_, War Crimes Cage, FWE 22, Drachau, Rumanian (Volksdeutschen), born 12 February 1920, at Bulgarus, Rumania. Former Residence: Number 378, Bulgarus, Rumania. Member: Waffen SS 1 August 1943 to May 1945.

Subject was a guard and tailor at the Gusen Concentration Camp from 10 August 1943 to 14 April 1945. He held the rank of Corporal in the SS Totenk, 511 Stuba Mauthausen. From April 1945 until May he served with the Combat Group Oberdonau.

A Status Report, Headquarters First Division, Civilian Internment Camp #9, dated 4 August 1947, Subject released on 24 July 1947, as not affected by the Nuremberg Trial, previously detained at Dachau-Hammelburg.

No additional information in the name of Subject is available at this source.
