The file on the above subject discloses no information which would justify placing him on the present list of defendants.

There are no documents, relating to this subject, which have been located from information now available. The document "Conferences before the Emperor" discloses no information as to this man. The eross reference files in the Document Rosm do not disclose information of any sort on this man from interrogations of other persons. However, USSES interrogations files Nos. 217, 238, 246 and 330 show that subject has been interrogated with a view of obtaining information which is not of a mature to be of benefit for the determination of subject as a defendant in this case.

To date ARISUE has not been interrogated by a member of the IPS Staff.

It is suggested, in conclusion, that should the Executive Conmittee desire further information on subject arrangements should be made for interrogation and further investigation of subject.
