Lieutenant (jg) F. W. CROOKS in a PB4Y-1P aircraft of Fleet Air Photographic Squadron ONE took off from Agana Airfield, Guam, M. I., on 23 May 1945 at 0650 King to Photograph enemy installations on Marcus Island. He arrived at his target at 1350 King and found overcast conditions making vertical photography impossible. He, therefore, let down to 9,000 ft. and was able to take oblique photographs from this altitude. No enemy interception or antiaircraft fire was encountered. Lieut. (jg) CROOKS landed at Agana at 1840 King.
