Gentlemen:

At about 12:45 P.M., June 24, 1954, I observed a strange object in the sky Northwest of my home in Danvers, Mass. The weather was clear, with a few small clouds drifting from the Northwest. I observed a small object, elliptical in shape, and completely whitish in color, travelling in a straight line, at an elevation of approximately  $50^{\circ}$  from the horizon, moving from the Southwest toward the Northeast.

The object traversed an arc of about  $45^{\circ}$  in approximately 30 seconds. I estimated the time on the basis of how long it took my son to go into the house and get my binoculars and return to me with them. During the time he was gone, I watched the object continuously. I was wearing polaroid sunglasses and I removed them and noted that the object became somewhat less distinct, but was otherwise unchanged. There was no noise of an airplane in the sky at the time, although the wind was toward me from the object. There was no vapor trail of any kind. The object did not glisten, but appeared to be very white. It was sharp and distinct against a clear blue sky.

When my son arrived with the binoculars, the object was becoming less distinct. By the time I had brought them to my eyes and focussed them, it had disappeared. A small cloud was in the area and it may have gone behind that, but I doubt it. It did not appear again, although I searched the area and along its projected trajectory for some minutes, both with the naked eye as well as with the binoculars.

On the following day at approximately the same hour, I observed several airplanes and other familiar objects, such as birds, flying through approximately the same area and I am certain that what I saw was none of these things.

Using the moon for comparison, which was visible at about the same location on the following day, I estimated the size of the object to have been apparently one-third its size, or approximately the size of an object one-eighth of an inch long when held at arms length.
