SCRANTON POSTOFFICE.

Classification of, and Postage Rates and Conditions Applying to
Domestic Mail Matter.

Domestic Mail Matter is divided into Four Classes as follows:

CLASSIFICATION:

Domestic mailmatter,—that is, mailmatter sent in the mails from some postoffice within the United States to some other postoffice within the same,—is divided into four classes, as follows:

FIRST-CLASS.—Written matter, namely letters, postal cards, and all matter wholly or partly in writing, whether sealed or unsealed (except manuscript copy accompanying proofsheets or corrected proofsheets of the same). All matter sealed or otherwise closed against inspection is also of the first-class.

SECOND-CLASS.—Periodical publications, namely, all newspapers and other periodical publications which are issued at stated intervals, and as frequently as four times a year, which bear a date of issue, and are numbered consecutively, are issued from a known office of publication, are formed of printed paper sheets, without board, cloth, leather or other substantial binding. To be entitled to entry in this class, such publications must be originated and published for the dissemination of information of a public character, or devoted to literature, the sciences, art, or some special industry, and must have a legitimate list of subscribers, and must not be designed primarily for advertising purposes, or for free circulation or circulation at nominal rates.

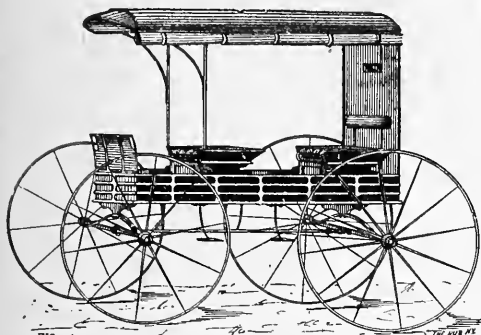

“Printed matter” is defined by statute to be “the reproduction upon paper, by any process except that of handwriting, of any words, letters, characters, figures, or images, or of any combination thereof, not having the character of an actual and personal correspondence.”

A “circular” is defined by statute to be “a printed letter, which, according to internal evidence, is being sent in identical terms to several persons,” and does not lose its character as such by writing therein the date, name of the addressee or of the sender, or the correction of mere typographical errors.

FOURTH-CLASS.—Merchandise, namely all matter not embraced in the first, second or third class which is not in its form or nature liable to destroy, deface or otherwise damage the contents of the mailbag, or harm the person of any one engaged in the postal service, and not above the weight provided by law. See the following paragraph.)

LIMIT OF WEIGHT OF MAIL MATTER.—No package weighing more than four pounds shall be received for conveyance by mail, except single books weighing in excess of that amount, and except books and documents published or circulated by order of Congress, or official matter emanating from any of the Departments of the Government or from the Smithsonian Institution.

Second-class matter is not subject to the four-pound limitation. The above limit of weight does not apply to matter in foreign mails regulated by postal conventions.

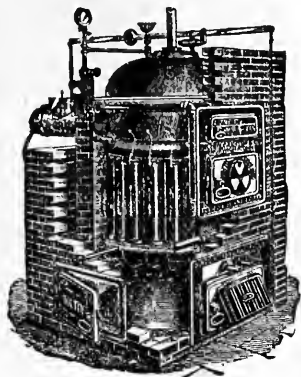

CLASSIFICATION OF MAIL MATTER.

FIRST-CLASS MATTER.

The Following Articles are Among those Subject to First-class Rate of Postage:—Autograph albums, containing writing; bank books, with written entries; bank checks filled out in writing, whether cancelled or not; written visiting cards; "old letters," whether sent singly or in bulk; stenographic or short-hand notes; diplomas, marriage, insurance or other certificates, filled out in writing; manuscript copy, when not accompanied with printed proof-sheets; type-written matter, and manifold copies of the same; drawings and plans, containing written words, letters or figures indicating size, price, dimensions, etc.; envelopes bearing written addresses; remailed postal cards wholly or partly in writing; printed assessment notices with amount due written or stamped in; printed price-lists, containing written figures; printed receipts with written signature; printed blank forms, filled out in writing; printed cards bearing a written date, where the date is not the date of the card, but gives information as to when the sender will call, or will deliver something mentioned in the printed part of the card, or is the date upon which something is acknowledged to have been received; indented or perforated sheets of paper, containing characters which can be read by the blind, when they contain actual, personal correspondence.

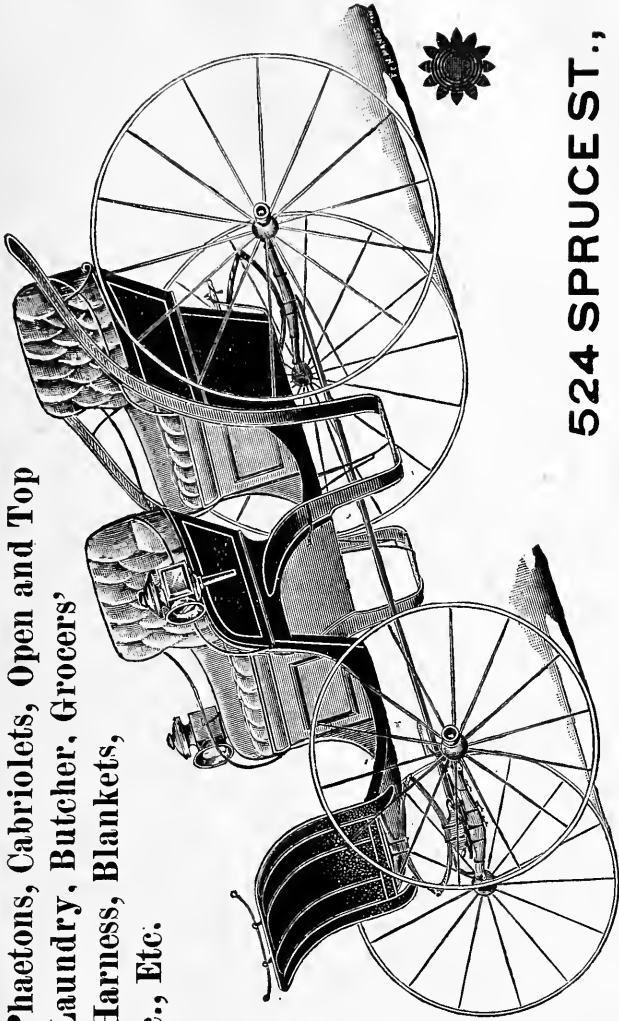

THIRD-CLASS MATTER.

*The Following Articles, when Printed upon Paper, and Containing no Writing, are Third-class Matter:—*Almanacs; printed legal and insurance blanks; blue prints; printed books; canvassing and prospectus books with printed sample chapters; blank check books and receipt books; printed cards; circulars, catalogues, and assessment notices wholly in print; Christmas and Easter cards; school copy books with printed lines and instructions for use; matter reproduced by the cyclostyle, hectograph, mimeograph, electric pen, or other similar processes easy of recognition; engravings and wood cuts; printed labels: lithographs; printed maps (on paper); music books, and sheets of music; printed blank notes, photographs; printed plans and architectural designs; postage stamps, cancelled or uncanceled; postal cards, bearing printed advertisements, mailed singly or in bulk; price-lists wholly in print; printed proof-sheets, with or without manuscript; printed tags; printed calendars; U. S. Treasury notes; printed valentines; press clippings, with name and date of paper stamped in; indented or perforated sheets of paper, containing characters which can be read by the blind, when not in the nature of personal correspondence.

Seeds, bulbs, roots, scions and plants are, by the act of July 24, 1868, also mailable at the third-class rate of postage. Under this head are included samples of wheat or other grain in its natural condition; seedling potatoes, beans, peas, chestnuts and acorns. NOT, HOWEVER, samples of flour, rolled oats, peeled barley, or other cereals which can only be used as articles of food; or cut flowers, dried plants, and botanical specimens; or foreign nuts and seeds (such as the coffee bean) used exclusively as articles of food, all of which are subject to postage at the fourth-class rate.

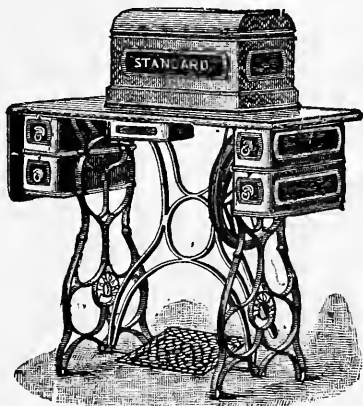

RATES OF POSTAGE.

For Lists of Articles of the First, see page 30; Third, see page 32; and Fourth Classes see page 38.

On First-class Matter.—The rate of postage on matter of the first class is as follows :

1) On letters and other written matter, except that specially authorized to pass at third-class rates, and on sealed matter or matter otherwise closed against inspection, two cents per ounce or fraction thereof.

2) On postal cards one cent each, the price for which they are sold.

3) On "drop letters" two cents per ounce or fraction thereof
ON SECOND-CLASS MATTER.—1. The rate of postage on second-class matter when sent by the publishers thereof, and from the office of publication, including sample copies, or when sent from a news-agency to actual subscribers thereto, or to other news-agents, is one cent per pound or fraction thereof.

The rate of postage on newspapers (excepting weeklies) and on periodicals not exceeding two ounces in weight, when the same are deposited in a letter-carrier office by publishers or news-agents for delivery by its carriers, is uniform at one cent each ; on periodicals weighing more than two ounces, two cents each.

Newspapers and periodicals when deposited by the publisher or news-agent in a letter-carrier office for general or box delivery, are subject to postage at the rate of one cent per pound ; when deposited by other than publishers or news-agents, for general or box delivery, the rate of one cent for four ounces or fractional part thereof.

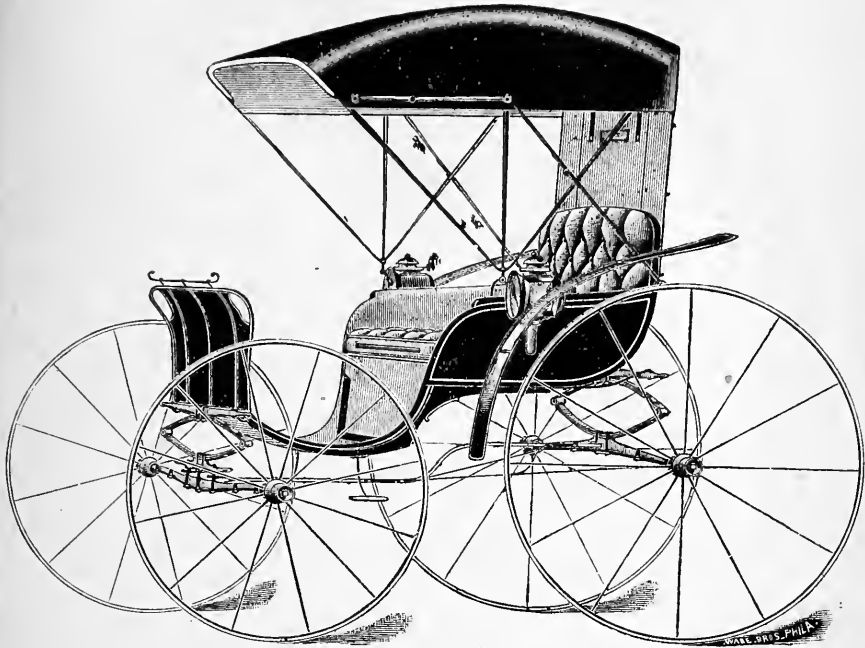

POSTAL RATES CONTINUED.

Weekly newspapers when deposited by the publisher or news-agent in a letter-carrier office, for delivery by carriers, or otherwise, are subject only to the rate of one cent a pound or fraction thereof.

All second-class publications, when sent by the publisher or a news-agent by mail, to a letter-carrier office located either in the county of publication or elsewhere, are subject to postage at the rate of one cent a pound, which entitles them to delivery by the carriers.

On Third-class Matter.—The rate of postage on third-class matter is one cent for each two ounces or fractional part thereof sent to a single address.

On Fourth-class Matter.—The rate of postage on fourth-class matter is one cent an ounce or fraction thereof sent to a single address.

By the act approved July 24, 1888, the postage on seeds, cuttings, roots, scions and plants is at the rate of one cent for each two ounces or fraction thereof. Dried plants, fruits and cut flowers are subject to the rate of one cent per ounce.

FOURTH-CLASS MATTER.

Under the head of Fourth-Class Matter are included the following articles:—Artificial flowers, photograph albums, blank autograph albums, blank books with printed headings, bill heads and letter heads, blank books, blotters, printed or unprinted; coin, blank cards, printed playing cards, Christmas and Easter cards, printed on other material than paper; samples of cloth, cut flowers, dried plants, botanical and geological specimens, blank diaries, envelopes, printed or unprinted; samples of flour, or other manufactured grain for food purposes; blank address tags or labels, dissected maps and pictures, proprietary medicines in original packages, metals, minerals, paper bags and wrapping paper, printed or unprinted; crayon pictures, oil or water color paintings, pen or pencil plans or drawings, if they contain no written words, letters, or figures giving size, dimension, distance, price, etc.; blank postal cards in bulk packages, printed dress charts and printed patterns, stationery, samples of merchandise, wooden rulers, containing printed advertisements; wall paper, queen bees, when properly packed; dried fruit, framed engravings, drawings or paintings, maps printed upon cloth, calendars, or other matter printed upon celluloid; paper napkins, photographs retouched with India ink or water colors, tin types, daguerreotypes, electrotype plates, and, in general, all articles not included in the other three classes of mail matter.

PREPAYMENT OF POSTAGE.

When and how Postage Should be Paid.—The rule of the statutes is prepayment of postage on matter not free in all cases. The exceptions to the rule are noted in on this page.

On First-class Matter.—The postage is to be prepaid by stamps affixed. But first-class matter will be dispatched if one full rate—two cents—in stamps be affixed, and the residue of the postage will be collected of the addressee before delivery.

As an exception to the rule of prepayment, letters of soldiers, sailors and marines in the service of the United States may be transmitted unpaid, when marked "Soldier's letter," "Sailor's letter," or "Marine's letter," as the case may be, and signed thereunder with his name and official designation by a field or staff officer, post or department commander, to whose command the soldier belongs, or by a surgeon or chaplain at a hospital where he may be; and in the navy and marine service, by the officer in command of the vessel, or surgeon on board, or officer commanding a naval hospital or detachment on shore; and the postage at single rates only will be collected on delivery.

On Second-class Matter.—When sent by publishers or newsagents at the pound rate, the postage is prepaid in money, and newspaper and periodical stamps are affixed to the stub of each receipt given; ordinary stamps cannot be used for this purpose.

On second-class matter, sent by other than publishers and newsagents the postage must be fully prepaid by postage stamps affixed.

On Third-class Matter.—The postage must be fully prepaid by stamps affixed.

On Fourth-class Matter.—The postage must be fully prepaid by stamps affixed.

POSTAGE DUE.

Postage Due, when to be collected.—When mail matter of the first-class is prepaid one full rate—two cents—it shall be forwarded to its destination charged with the unpaid rate, to be collected on delivery.

Double Postage, when to be collected.—If any mail matter on which by law the postage is required to be prepaid at the mailing office, shall, by inadvertence, reach its destination without *any* prepayment, double the prepaid rates shall be charged and collected on delivery.

The postage due and to be collected on short-paid or unpaid matter inadvertendly dispatched is indicated by postage-due stamps, which the postmaster at the office of destination is required to affix and cancel before delivery.

Postmasters cannot lawfully accept postage stamps in payment of postage remaining due on letters. The amount due must invariably be paid in cash.

SPECIAL DELIVERY.

Law regulating the immediate delivery of mail matter.—The law establishing the special delivery system provides for the issue of a special stamp of the face valuation of ten cents, which, when attached to a letter or package (in addition to the lawful postage thereon) will entitle such letter or package to immediate delivery within the carrier limit of a free delivery office between the hours of 7 a. m. and 11 p. m., and within a radius of one mile from the postoffice at all other offices between 7 a. m. and 7 p. m., by messengers, who, upon delivery, will procure receipts from the parties addressed, or some one authorized to receive them.

When a special delivery letter is offered at its address, and delivery cannot be effected for any reason (such as the premises being closed, an error in direction, the absence of any person authorized to sign the receipt, or any other similar cause), it cannot be again offered for delivery, either at the original address or elsewhere, as a special delivery letter, but it will be delivered, as soon after its return as possible, by letter carrier. If the person addressed has removed, it will be forwarded free to its proper address, if it be known, either in this city or at another postoffice, but will in either case be delivered only as an ordinary and not as a special delivery letter.

An ordinary 10-cent postage stamp, or its equivalent in postage stamps of other denominations, affixed to a letter will NOT entitle it to special delivery.

Postmasters are not required to make special delivery on Sunday. Many of them do, however, and a list of the principal offices making delivery on Sundays of special delivery matter is here given:

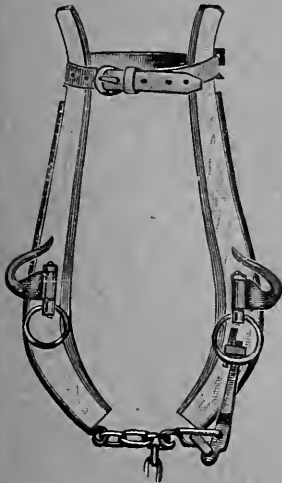

GENERAL PROVISIONS.

Folding and Addressing Second-class Matter.—Publishers and news-agents are enjoined to fold their publications to a size not larger than 9 by 12 inches, and when second-class matter is addressed by them, unwrapped (that is, when wrapped in bulk, each paper bearing the addressee's name), it should uniformly be upon the upper right-hand corner of the first page; and whether wrapped in bulk or singly, the entire address required should be in a clear handwriting or plain type not smaller than long primer. A disregard of this request is liable to delay transportation and delivery, as postmasters are instructed "to hold illegibly addressed and improperly folded matter of this character until all other is distributed.

Examination of Second-class Matter.—Postmasters should frequently examine publications offered for mailing at the second-class rate of postage to ascertain whether they violate the rules prescribed by law for their admission to said class.

Advertisements to be Permanently Attached.—All advertisements in periodicals must be *permanently* attached thereto by binding, printing, pasting, or otherwise, and must be of uniform size of the pages of the publication.

Second, third or fourth-class matter containing any writing or printing unauthorized by law cannot be delivered, except upon payment of postage for matter of the first-class.

PERMISSIBLE ADDITIONS TO MATTER OF THE SECOND, THIRD AND FOURTH CLASSES.

What is Permissible to be Written or Printed on Mail Matter not of the First-class.—Mailable matter of the second-class shall contain no writing, print or sign thereon or therein in addition to the original print, except as herein provided, to-wit: The name and address of the person to whom the matter shall be sent; index-figures of subscription-book either printed or written; the printed title of the publication and the place of its publication; the printed, or written name and address without addition of advertisement of the publisher, or sender or both and written or printed words or figures, or both, indicating the date on which the subscription to such matter will end; the correction of any typographical error; a mark except by written or printed words to designate a word of passage to which it is desired to call the attention; the words "sample copy," when the matter is sent as such; the words "marked copy," when the matter contains a marked item or article. And publishers and news-agents may inclose in their publication bills, receipts and orders for subscriptions thereto, but the same shall be in such form as to convey no other information than the name, place of publication, subscription price of the publication to which they refer, and the subscription due thereon. (Act of January 20, 1888. See also instructions from Third Assistant Postmaster-General, page 103 this GUIDE.) When matter mailable at second-class rate is prepaid at the third-class rate, it shall be deemed third-class matter and entitled to all the permissible printing or writing authorized for matter of the third-class. The number of copies inclosed may be indicated upon the wrapper or face of the package.

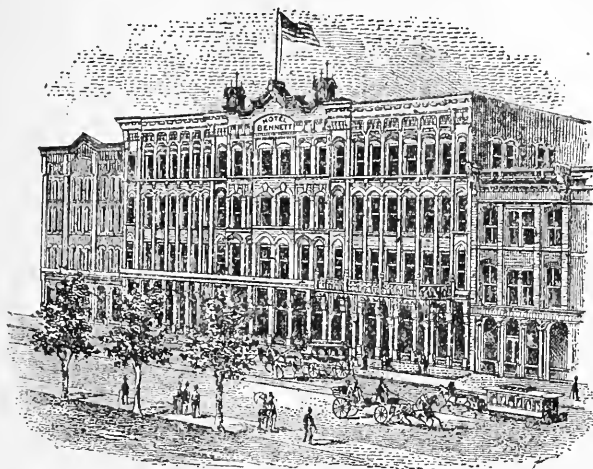

SECOND-CLASS MATTER.—Continued.

Bills, receipts, and orders for subscriptions, in order to be mailable with second-class publications at the pound rate of postage, must be "in such form as to convey no other information than the name, place of publication, subscription price of the publication to which they refer, and the subscription due therein." The expression "subscription price" will in every case hereafter be construed by the Department as the regular stated price of the publication, without reference to any premium that may be offered.

Forms of Bills, Receipts and Orders Accompanying Second-class Matter.—Bills or receipts printed in substantially the following form are admissible under the preceding act :

_____, subscription, in advance.

Received payment for the _____ Weekly from _____ to _____.

A bill or receipt for subscription may include the names of more than one publication and their term of subscription, provided they are all published by the same individual or company, or sent by the same news-agent, and may include any period of subscription or any number of shipments to a news-agent.

Orders for subscription may indicate the term or period for which subscription is ordered. The written or printed words or figures, or both, to indicate when the subscription will end, may be placed upon the matter itself, upon the wrapper or upon the bills, receipts or orders which may be inclosed therewith.

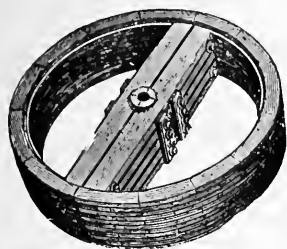
Permissible Additions to Third-class Matter.—Upon matter of the third-class, or upon the wrapper or envelope inclosing the same, or the tag or label attached thereto, the sender may write his own name, occupation, and residence or business address, preceded by the word "from," and may make marks other than by written or printed words to call attention to any word or passage in the text, and may correct any typographical errors. There may be placed upon the blank leaves or cover of any book, or printed matter of the third-class, a simple manuscript dedication or inscription not of the nature of a personal correspondence. Upon the wrapper or envelope of third-class matter, or the tag or label attached thereto, may be printed any matter mailable as third-class, but there must be left on the address side a space sufficient for a legible address and necessary stamps. (Act of January 20, 1888.)

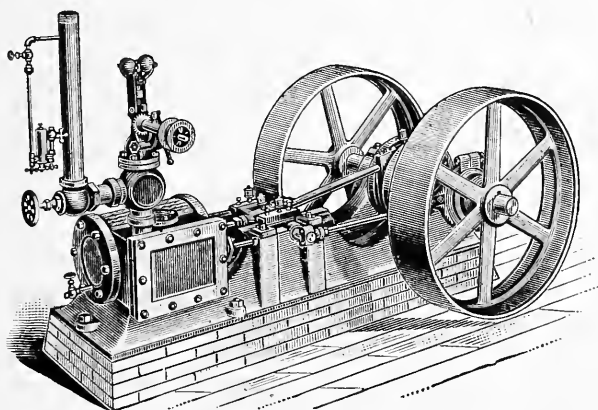

Permissible Writing or Printing upon or with Fourth-class Matter.

—With a package of fourth-class matter prepaid at the proper rate for that class, the sender may inclose any mailable third-class matter, and may write upon the wrapper or cover thereof, or tag or label accompanying the same, his name, occupation, residence or business address, preceded by the word "from," and any marks, numbers, names or letters for the purpose of description, or may print thereon the same, and any printed matter not in the nature of a personal correspondence, but there must be left on the address side or face of the package a space sufficient for a legible address and necessary stamps. (Act of January 20, 1888.)

The tag or label, with the printing or writing authorized thereon, may be attached to the whole package, or separate tags or labels, bearing the same, may be attached to each of one or more articles, contained in the package.

In all cases directions for transit, delivery, forwarding or return shall be deemed part of the address; and the Postmaster-General shall prescribe suitable regulations for carrying this section (Sections 308, 318 and 323 P. L. and R.,) into effect. (Act of January 20, 1888.)

UNMAILABLE MATTER.

126. *What is Unmailable.*—(See § 330 P. L. & R.) Unmailable matter includes all matter which is by law, regulation or treaty stipulation prohibited from being transmitted in the mails, or which, by reason of illegible, incorrect, or insufficient address of person, or office, cannot be forwarded to destination or delivered to the person for whom intended. Unmailable matter is classified thus:

1. *Held for Postage.*—Or matter insufficiently prepaid to entitle it to be forwarded. This includes domestic matter of the first class which is not prepaid at least one full rate, two cents, and all other domestic matter not fully prepaid.

As to matter unmailable when addressed to or received from foreign countries, see "Prohibited Articles."

2. *Misdirected.*—That is, matter without address or so incorrectly, insufficiently or illegibly addressed that it cannot be forwarded to its destination. This includes "nixes," the term applied to designate mail-matter not addressed to a post office, or addressed to a post office without the name of the State being given, or otherwise so incorrectly, illegibly or insufficiently addressed that it cannot be transmitted. (P. L. & R. § 996.)

3. *Destructive.*—That which from its harmful nature is forbidden to be in the mails. Among these are: Poisons, explosive or inflammable articles, live or dead (and not stuffed) animals, insects or reptiles a bad odor; vinous, spirituous and malt liquors, and liquids liable to explosion, spontaneous combustion or ignition by shock or jar (such as kerosene oil, naphtha, benzine, turpentine and other liquids of like character).

4. *Specimens of Cholera Germs.*—Disease germs, discharges of any kind from diseased persons, or other things of like character, no matter how securely put up. (Order Postmaster-General, June 1, 1893).

5. *Coin and Jewelry.*—That matter, to wit, coin, jewelry, or other precious articles, which by the provisions of the conventions with foreign countries are prohibited from being sent in mails to foreign countries. (See note 20, p. 928, of this GUIDE).

6. *Obscene Matter.*—This embraces: Every obscene, lewd, or lascivious book, pamphlet, picture, paper, writing, print, or other publication of an indecent character; every article or thing designed or intended for the prevention of conception or procuring abortion; every article or thing adapted or intended for any indecent or immoral use; every written or printed card, circular, book, pamphlet, advertisement, or notice of any kind giving information, directly or indirectly, where, how or from whom, or by what means any of the hereinbefore mentioned matters, articles, or things may be obtained or made; every letter upon the envelope of which, or postal card upon which indecent, lewd, obscene, or lascivious delineations, epithets, terms, or language may be written or printed. (See § 333 P. L. & R).

7. *Lottery Matter.*—That is, letters and circulars known to be concerning lotteries, so-called gift concerns or other similar enterprises, offering prizes, or concerning schemes devised and intended to deceive and defraud the public for the purpose of obtaining money under false pretenses. (See § 331 P. L. & R).

8. *Mutilated.*—That matter becomes unmailable which is recovered from wrecked or burned mail cars or vessels, or which has been so damaged by any other means that it cannot be forwarded to its destination. This includes all matter of value found loose in the mails, separated from the wrapper, label, or envelope containing the address, so that the direction cannot be known; and all matter which is recovered from deprecations on the mails, which the Postmaster-General is required to restore to the owners when ownership is proved.

9. *Excess of Weight and Size.*—Those packages of domestic third and fourth-class matter more than four pounds, except single books exceeding that weight, and official matter emanating from the Departments, and books and documents published and circulated by order of Congress, and of foreign matter, which are in excess of the weight or size fixed by the treaty stipulation as the maximum for such matter (see note 20, page 928, this GUIDE). The limit of weight *does not apply* to second-class matter mailed in packages at the pound rate or at the rate of one cent for each four ounces.

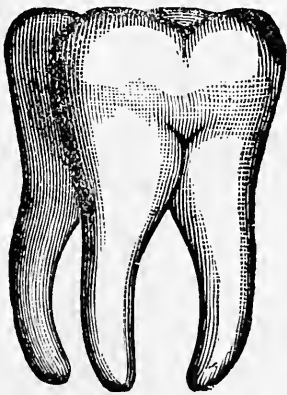

List of Articles Declared Unmailable.

1. TO ALL DESTINATIONS, FOREIGN OR DOMESTIC.—*Animals, live or dead, *Articles liable to spontaneous combustion; *Comb Honey; *Destructive matter, *i. e.*, articles of a form or nature liable to injure the mails or the person of those handling them when not properly wrapped or secured; *Explosives; *Fruits; *Inflammable articles; *Lottery matter, *i. e.*, letters and circulars known to be concerning lotteries, gift concerts and similar enterprises; *Letters or postal cards addressed to go around the world; *Malodorous substances, such as guano; *Malt or spiritous liquors; *Obscene, lewd, lascivious, libelous, scurrilous, defamatory or threatening publications or pictures, whether written or printed; *Packages in excess of the limit of size and weight, or upon which the postage is not paid according to law or treaty stipulation; *Poisons; *Publications issued in violation of United States copyright law; *Vegetable matter liable to decomposition.

2. TO ALL DESTINATIONS, EXCEPT AS STATED IN NOTES A. AND B.—*Confectionery; *Fatty substances; *Insects; *Liquids and matter which easily liquefies; *Oils; *Pastes; *Powder substances; *Reptiles; *Salves.

NOTE A.—Liquids, oils and fatty or powdered substances (except such as are dangerous, inflammable, explosive, or exhale a bad odor), are admitted in the mails to Argentine Republic, Austria, Belgium, Bolivia, Bulgaria, Cameroons, Chili, Congo, Curacao, Denmark, Dutch Guiana, Egypt, France and the French Colonies, Germany, French, Hawaiian Kingdom, Hayti, India, (British), Italy, Japan, Luxemburg, Netherlands, Netherland Colonies, Norway, Peru, Portugal and her colonies, Roumania, Salvador, Servia, Siam, Spain and her colonies, Sweden, Switzerland, Tunis and Turkey, subject to the rate of postage and limits of size and weight prescribed for "Trade Samples" when properly secured, *viz.*, they must be placed in thick glass bottles, hermetically sealed; the bottles must be placed in a wooden box containing sufficient spongy matter to absorb the contents if the bottle should break; the whole to be enclosed in a metal case bearing the address; the box and case to be so closed that they can be easily opened for examination of the contents.

NOTE B.—Articles named in paragraph two are admitted in Domestic mails when properly secured, *viz.*, liquids and oils which are not alcoholic, explosive, inflammable, or liable to spontaneous combustion, and pastes, salves or other articles easily liquefiable, when bottle or box containing such matter is securely packed in a wooden or metal case or tube, water tight and sufficiently strong to resist rough handling; pepper, snuff or other powder not explosive or poisonous, when secured in strong, tightly covered boxes; confectionery, hard soap, *etc.*, when wrapped in strong paper boxes; queen bees and their attendant bees, and dried insects and reptiles, when put up so as to prevent injury to the mails or the persons of those handling them.

3. TO ALL COUNTRIES OF THE U. P. U., IN WHICH THEY ARE LIABLE TO CUSTOMS DUTY. (See note).—*Precious articles, such as jewelry, precious stones and gold and silver substances.

NOTE.—The only places to which they may be sent so far as known to the department are Bermuda, Falkland Island, Germany and the German Protectorates, Gibraltar, Hong Kong, Labuan, Lagos, Malta, Monseratt, Senegambia, Sierra Leone, and Straits Settlements.

4. TO PLACES SPECIALLY MENTIONED, AS FOLLOWS:—All sealed packages, which from their form and general appearance, evidently are not letters, when addressed to Canada, Mexico, Shanghai; Correspondence marked on the outside with the declared value of contents, when addressed to Austria, Belgium, Denmark, Danish Colonies, Egypt, France and her Colonies, Germany, Hungary, Italy, Luxemburg, Norway, Netherlands, Portugal and her colonies, Roumania, Russia, Servia, Sweden or Switzerland; Merchandise other than bona fide "Trade Samples" when addressed to Mexico, unless sent by "Parcels Post;" Missals, breviaries, and other liturgical books pertaining to the Catholic religion, when addressed to Spain; Newspapers and other political publications, (except those sent to members of the Imperial family, ministers of the Empire, or members of the Diplomatic Corps), non-political publications (except those sent to the Public Imperial Library, the Academy of Sciences, the higher educational establishments or established book stores), when addressed to Russia, unless subscribed for at Russian Postoffices; Paste-board drawing models, when addressed to Russia or Sweden; Plants, trees, shrubs, roots, bulbs, addressed to Greece, Italy or Roumania. Police Gazette addressed to Canada; *Publications issued in violation of the copyright law of the country addressed to Canada and places named in "Parcels Post" list. Samples of raw or spun silk exceeding 3½ ozs., when addressed to Italy, and except samples not exceeding 3 ozs., when addressed to Great Britain.

To take all means to prevent the loss of a money-order.

To be careful on taking out a money-order to state correctly the given name as well as the surname of the person in whose favor it is to be drawn. (See P. L. & R., § 1251.)

To see that the name and address of the person taking out the money-order are correctly made known to the person in whose favor it is drawn.

Neglect of these instructions will risk the loss of the money, besides leading to delay and trouble in obtaining payment.

No application for compensation for alleged injury from delay in the payment of money-orders can be entertained by the Department; but persons aggrieved by delays of this kind, whether occasioned by non-receipt of advices of orders, by mistakes resulting from carelessness in the filling out of orders or advices, or by alleged lack of funds at the office drawn upon, should make the same known to the Department by addressing the Superintendent of the Money-Order System, Washington, D. C.

The fees or charges for Domestic Money-Orders are as follows:

For orders not exceeding \$2.50.....	3 cents
For orders not exceeding \$5	5 cents
For orders exceeding \$ 5 and not exceeding \$10	8 cents
For orders exceeding \$10 and not exceeding \$20	10 cents
For orders exceeding \$20 and not exceeding \$30	12 cents
For orders exceeding \$30 and not exceeding \$40	15 cents
For orders exceeding \$40 and not exceeding \$50	18 cents
For orders exceeding \$50 and not exceeding \$60	20 cents
For orders exceeding \$60 and not exceeding \$75	25 cents
For orders exceeding \$75 and not exceeding \$100.....	30 cents

The maximum amount of a single order is \$100, and no more than three Domestic orders may be issued in one day to the same remitter, in favor of the same payee, payable at the same post office. (See P. L. & R. §§ 1248 and 1249.)

A person applying for a money-order will be required to write the particulars upon a form of application which will be furnished him therefor by the postmaster.

Parties procuring money-orders should examine them to see that they are properly filled up and stamped. This caution is necessary to avoid difficulties in the way of payment.

The person who presents a money-order for payment must be identified if unknown to the postmaster, unless identification has been expressly waived by the remitter of the order on his application therefor. (See P. L. & R., §§ 1270 and 1253.)

More than one endorsement on a money-order is prohibited by law; and a second or any subsequent endorsee, to obtain payment, must forward the order, through the post office at which it was issued or the one on which it is drawn, to the Department, with an application for a duplicate to be issued in lieu thereof, and must furnish proof of the genuineness of the endorsements.

A money-order may be repaid at the office of issue within one year, provided it bears not more than one endorsement. The fee will not be refunded. (See P. L. & R., §§ 1310-11.)

When a money-order has been lost by either remitter, payee or indorsee, a duplicate thereof will be issued by the Department free of charge, to the owner of the original, upon his making application (stating the circumstances of the loss), to be forwarded by the issuing or the paying postmaster, each of whom will be required to furnish a certificate that the original order had not been, and would not be, paid or repaid, as the case may be.

A duplicate order can be drawn only on the issuing or the paying office of the original order, and becomes invalid if it bears more than one indorsement, or be not presented for payment within one year from its date. (See P. L. & R., § 1294.)

The issue of money-orders on credit is prohibited under severe penalties. Checks, drafts or promissory notes are in no case to be received by postmasters for money-orders.

A money-order may be paid upon a written order, or power of attorney, from the payee, as well as upon his indorsement. The written order or power of attorney must be filed with the paying postmaster.

A money-order which has not been paid within one year from the date of its issue should be forwarded to the Department with an application for duplicate, to be furnished by the issuing or paying postmaster.

INTERNATIONAL MONEY-ORDERS.

There are now in operation postal conventions for the exchange of money-orders between the United States and the following countries, viz.: Switzerland, Great Britain and Ireland, Germany, France, Italy, Canada, Newfoundland, Jamaica, New South Wales, Victoria, New Zealand, Queensland, the Cape Colony, the Windward Islands (embracing the islands of Barbados, Grenada, St. Vincent and St. Lucia), the Leeward Islands (consisting of the Presidencies of Antigua, St. Christopher—Nevis, Dominica, Montserrat, and the Virgin Islands), Belgium, Portugal, Tasmania, the Hawaiian Kingdom Sweden, Japan, Norway, Denmark, the Netherlands, the Bahama Islands, the Colony of Trinidad and Tobago, Austria, Hungary, British Guiana, the Grand Duchy of Luxemburg, Bermuda, South Australia and Salvador.

Upon receiving an International Money-order, properly filled out from the issuing postmaster, the remitter must send it, at his own cost.

In which case it is of no value except as evidence of the deposit by him of the sum therein mentioned, and he should be advised that another and different form of order will be forwarded to the payee by the exchange office in the country of payment.

POSTAL CARDS.

A postal card with a statement of account written thereon may be transmitted in the mails when it does not contain anything reflecting injuriously upon the conduct or character of another, or a threat of any kind, or any other matter forbidden by law.

The Department does not hold the usual legal notices sent out by tax collectors that tax is due, or about to become due, written or printed upon postal cards, to be unmailable.

It is the Postmaster-General who is authorized by law to determine the quality, form and size of postal cards, and to prescribe the rules and regulations under which they may be sent in the mails, and it is not within the discretion of others to change the card so adopted. Such change of form or face will render the card unmailable.

When anything whatever, except an address label, is attached to a postal card transmitted in the mail, the same becomes subject to additional postage.

Postmasters are forbidden to back-stamp postal cards on the side intended for the communication. The back-stamp must be made only on the side intended for the address, and so as not to interfere with the address.

SPECIAL DELIVERY.

For Instructions as to Special Delivery, see Sections 633 to 665, Postal Laws and Regulations, Ed. 1893.

Any article of mailable matter bearing a ten-cent special delivery stamp in addition to the lawful postage is entitled to immediate delivery on its arrival at the office of address, between the hours of 7 A. M. and 11 P. M., if the office be of the free-delivery class, and between the hours of 7 A. M. and 7 P. M., if the office be other than a free-delivery office.

To entitle such a letter to immediate delivery, the residence or place of business of the addresses must be within the carrier limits of a free-delivery office and within one mile of any other office. Special delivery stamps are not available for the payment of postage, nor can ordinary postage stamps be used to secure immediate delivery of mail matter. Attention of postmasters is called to Act approved January 16, 1889. (§ 634 P. L. & R, 1893).

It is not a violation of postal law to send dunning communications by mail, when the same are sent under cover of envelopes which do not bear thereon written or printed words or display, objectionable to the law. (See § 332, P. L. & R.)

BOXES AND BOX RENTS.

Under existing law, all boxes erected in post offices by box-holders shall become the property of the United States, and rent must be collected thereon at rates to be fixed by the Department, and such rates can only be changed by the Department.

The Post Office Department regulates the rent of boxes in post offices.

An individual member of a firm is entitled to have the mail of his family placed in the post office box rented by the firm. If the box will not accommodate all the mail the firm must rent another.

Postmasters must deliver mail to persons calling for the same in their order, whether they be box-holders or not.

A postmaster has no right to use the boxes or the general delivery of his office for the distribution of bills or circulars relating to his own private business without prepayment of postage thereon.

It is provided by law that no box at any post office shall be assigned to the use of any person until the rent thereon has been paid for one quarter in advance.

Parcels Post.

MERCHANDISE,

Other than samples, may be sent by "Parcels Post" to the places named below, subject to the following regulations:

Parcels must be secure and substantially packed, and so wrapped or enclosed that the contents may be easily examined; must not contain any communication of a personal character; nor contain other parcels intended for delivery at another address than that borne by the parcel itself; nor contain any of the articles denoted by * in "List of matter declared unmailable."

Parcels must be plainly and fully addressed, and, in the upper left hand corner, bear the words "Parcels Post," and the name and address of the sender; must be presented at the mailing postoffice to the postmaster or person in charge, and a written declaration made on a prescribed form (form furnished by the postmaster), giving description, value, etc., of the parcels and contents.

CUSTOMS DUTY.

Articles liable to customs duty will be charged therefor and collected at destination, except that articles manufactured in the United States are admitted in the Hawaiian Kingdom "duty free," if the fact is so stated in the sender's written declaration.

LIMITS OF SIZE AND WEIGHT.

Parcels to places marked †† must not exceed two feet in length, nor four feet in girt; to the other countries the greatest length is three feet six inches, and greatest length and girt combined is six feet. The maximum weight for all destinations is 11 pounds.

POSTAGE.

The rate of postage is 12 cents per pound or fraction thereof, and it must be fully prepaid with stamps, to be affixed by the sender. On delivery of a parcel weighing one pound or less, the addressee will be required to pay a fee of five cents; if more than one pound, at the rate of one cent on each four ounces.

REGISTRATION.

Parcels may be registered to any country named in list, except Barbadoes. Fee, 10 cents.  This secures a return receipt.

U. S. LETTER SHEET ENVELOPE.

The Postoffice Department has issued a letter sheet and envelope combined, which is called the "U. S. Letter Sheet Envelope." They are issued in denomination of two cents only, and are for sale at the larger postoffices. The communication is written upon the inside, and it is then folded as designated by the perforated lines, and sealed at the ends and top. It is then ready to be mailed after the proper directions have been placed upon it.

They are put up in pads of twenty-five, fifty and one hundred, at the following prices: One, three cents; two for five; three for seven; 109 for \$2.30.

POSTAGE STAMPS.

Only postage stamps are used in the mails. No other stamps of any kind can be used for the purpose. Only United States money will be received in payment for stamps. Silver or gold coin with holes, or pieces nicked from the sides, are not taken, and stamps are sold for cash only.

Extract from the Laws.—Any person who shall use, or attempt to use, in payment of postage, any cancelled postage stamps, whether the same has been used before or not, or who shall by any means remove, or attempt to remove, or assist in removing, marks from any postage stamp or postage stamps, with intent to use the same, or from which such cancellation marks have been removed, or who shall sell, or offer to sell, any such stamp or stamps, or who shall use, or attempt to use the same in payment of postage, or who shall remove the superscription from any stamped envelope or postal card that has been once used in payment of postage, with intent to again use the same for a like purpose, shall be deemed guilty of a misdemeanor, and shall, on conviction thereof, be punished by imprisonment for not less than six months, nor more than one year, or by a fine of not less than \$100, nor more than \$500 for each offense, or by both such fine or imprisonment, in the discretion of the court. * * *

Any person who shall use, or attempt to use, in payment of the postage on any mail matter, conveyed by mail or otherwise, any postage stamps or stamped envelopes, or any stamps cut from any such stamped envelopes which have been before used for a like purpose, shall be liable to a penalty of \$50.

The exchange of postage stamps or stamped envelopes for those of other denominations, to accommodate private parties, is prohibited. Postmasters will not be permitted to return to the Department unserviceable stamps or stamped envelopes that may be acquired in this way. Postmasters are not obliged to accept in payment for postage stamps, or stamped envelopes, wrappers, etc., any currency which may be so mutilated as to be uncurrent, or the genuineness of which can not be clearly ascertained. They are not obliged to affix stamps to letters, nor are they obliged to make change, except as a matter of courtesy. Neither should they give credit for postage.

Prices of Envelopes and Newspaper Wrappers.

STAMPED ENVELOPES AND NEWSPAPER WRAPPERS SPOILED IN DIRECTING.

The postage on stamped envelopes and newspaper wrappers spoiled in directing will be refunded in stamps by the postmaster, if satisfied that they have never been sent by mail, and that the misdirection actually occurred at the place where the redemption is claimed; also, provided, that such envelopes shall be presented in a whole condition. (See Sec. 170, Postal Regulations of 1879.)

SPECIAL REQUEST ENVELOPES.

When ordered in quantities of 500 and upward, of any specified denomination, the Department will, if desired, print on the upper left hand corner of any of the below described envelopes (except Nos. 4, 6 and 12, circulars and newspaper wrappers), without additional charge, the name (excluding business employment) and postoffice address of purchasers (the postoffice as officially established and published in the Postal Guide), with a request to return, if unclaimed within a given time. These are officially designated as Special Request Envelopes, and individuals must in all cases order them through postmasters, and not by direct application to the Department.

SALES OF IRREGULAR QUANTITIES.

In making sales of envelopes and wrappers in quantities other than as below set forth, it is expected that postmasters will evince a proper spirit of accommodation, but they are not required to lose the fraction of a cent, and if the postmaster cannot make change, the purchaser must tender the exact amount for the number required.

When the schedule price of a single envelope is three cents, and that of a single wrapper is two cents, and both are purchased at the same transaction, four cents, and not five cents, will be required, and the same principle applies to all similar sales of different qualities or denominations. That is, where several envelopes of different styles are sold, the postmaster will retain only the fraction of a cent on the whole purchase, and not on each separate envelope.

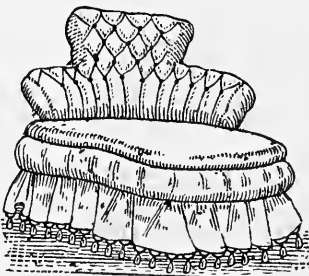
Letter Carriers are required to make collections of Mail Matter from the street letter boxes on their respective routes at the time of making their delivery trips.

Suggestions to the Public on Postal Subjects.

How to Direct and Mail Letters.—Mailmatter should be addressed legibly and completely, giving the name of the postoffice, and, if to a city having a free delivery, the street and number, and the postoffice box of the person addressed should be added, if have one. It is well to give the county also, and to *spell the name of the State in full*. To secure return to the sender in case of misdirection or insufficient payment of postage, his name should be written or printed upon the upper left-hand corner of all mail matter. The matter will then be returned to the sender, if not called for at its destination, without going to the Dead Letter Office, and, if a letter, it will be returned free.

Dispatch is hastened by mailing early, especially when large numbers of letters, newspapers, or circulars are mailed at once.

When numbers of letters or circulars are mailed together, addressed to the same destination, it is well to tie them in bundles with the addresses facing the same side. On letters for places in foreign countries, especially Canada and England, in which many postoffices have the same name as offices in the United States, the name of the country as well as postoffice should be given in full. Letters addressed, for instance, merely to "London," without adding "England," are frequently sent to London, Canada, and *vice versa*, thereby causing delay, and often serious loss. Letters addressed to Burlington, N. S. (Nova Scotia), often go to Burlington, New York, on account of the resemblance between S and Y when carelessly written.

Avoid Thin Envelopes.—Thin envelopes, or those made of weak or poor, unsubstantial paper, should not be used, especially for large packages. Being often handled, and in the mailbags subjected to pressure and friction, such envelopes are frequently torn open or burst, without fault of those who handle them. It is best to use Stamped Envelopes wherever it is convenient and practical to do so.

SUGGESTIONS TO THE PUBLIC---Continued.

Register Valuable Matter.—All valuable matter should be registered. Registry fee is eight cents, which, with full postage, must be prepaid, and name and address of sender must be given on the outside of envelope or wrapper. Money should be sent by a money order or registered letter; otherwise it is liable to loss.

The Convenience of Letter Boxes.—Patrons in cities where letter carriers are employed are advised to provide letter boxes at places of business or private residences, thereby saving much delay in the delivery of mail matter.

The Use of Mailing Boxes.—When dropping a packet in a mailing box, or into the receptacle at the postoffice, care should be taken that the packet falls into the box, and does not stick in the passage. Mail matter deposited in any receptacle erected by the Department, such as street mailing boxes for the reception of mail matter to be collected by letter carriers, or boxes in railroad depots for the reception of matter to be collected by employees of the railway mail service, cannot be reclaimed except as provided for by Rulings 192 and 194 of this GUIDE. On such receptacles erected in railroad depots a notice should be affixed that they are not intended for reception of matter for city delivery.

Affix Stamps Firmly.—Postage Stamps should be placed on the upper right-hand corner of the address side of all the mail matter, care being taken that they are *securely affixed*.

What Postage May be Paid With.—Postmasters are not required to accept as payment for postage stamps, etc., any currency which may be so mutilated as to be uncurrent or as to render its genuineness doubtful. Nor are they required to receive more than twenty-five cents in copper or nickel coins, nor to affix stamps to letters, nor to make change, except as a matter of courtesy. They must not give credit for postage.

General Suggestions.—A subscriber to a newspaper or periodical who changes his residence and postoffice should at once notify the publisher, and have the publication sent to his new address.

Publishers and news agents, mailing second-class matter in quantities, will facilitate its distribution, and often hasten its dispatch, by separating such matter by States and Territories and the larger cities.

Hotel matter, that is, matter addressed for delivery at hotels, should be returned to the postoffice as soon as it is evident that it will not be claimed.

Proprietors of hotels, officers of clubs and boards of trade or exchanges, should not hold unclaimed letters longer than ten days, except at the request of the person addressed, and should re-direct them for forwarding, if the present address is known; otherwise they should be returned to the postoffice.

SUGGESTIONS TO THE PUBLIC---Continued.

All inquiries, whether from postmasters or the public, relative to lost or missing mail matter of every description, both foreign or domestic, ordinary and registered, should be addressed to the Fourth Assistant Postmaster-General, Division of Postoffice Inspectors and Mail Depredations, Postoffice Department, Washington, D. C., to whom all losses or irregularities should be reported as soon as possible after the loss. An early report is necessary, as the chance of recovery is thereby increased.

All inquiries relative to mail matter known to have been sent to the Dead Letter Office, should be addressed to the First Assistant Postmaster-General, Dead Letter Office: and in such cases the letter of inquiry must state to whom and what postoffice the article was addressed, and give the name and full address of the writer or sender, the date and place of mailing, and a brief description of the contents. If it is known when the missing matter was sent to the Dead Letter Office, the date and the reason for sending should be given. If registered, the number should also be furnished.

Packages of third and fourth-class matter, except single books, must not exceed four pounds in weight. (See P. L. & R., §§ 320, 326.)

Packages of Mutilated currency, addressed to the Treasurer of the United States for redemption may be registered free of charge for registry, but the postage thereon must be prepaid at letter rates. (See P. L. & R., §§ 1039, 1040.)

Considerable inconvenience to the employees of the Department and delay to mailmatter result from the failure of the public to properly address mailmatter intended for delivery at offices in North and South Dakota; large quantities of such matter being simply addressed "Dakota." Postmasters should avail themselves of every opportunity of impressing upon the patrons of their offices the necessity for properly addressing mail for these two states.

Letters addressed to persons temporarily sojourning in a city where the Free Delivery System is in operation should be marked "Transient" or "General Delivery," if not addressed to a street and number or some other designated place of delivery.
