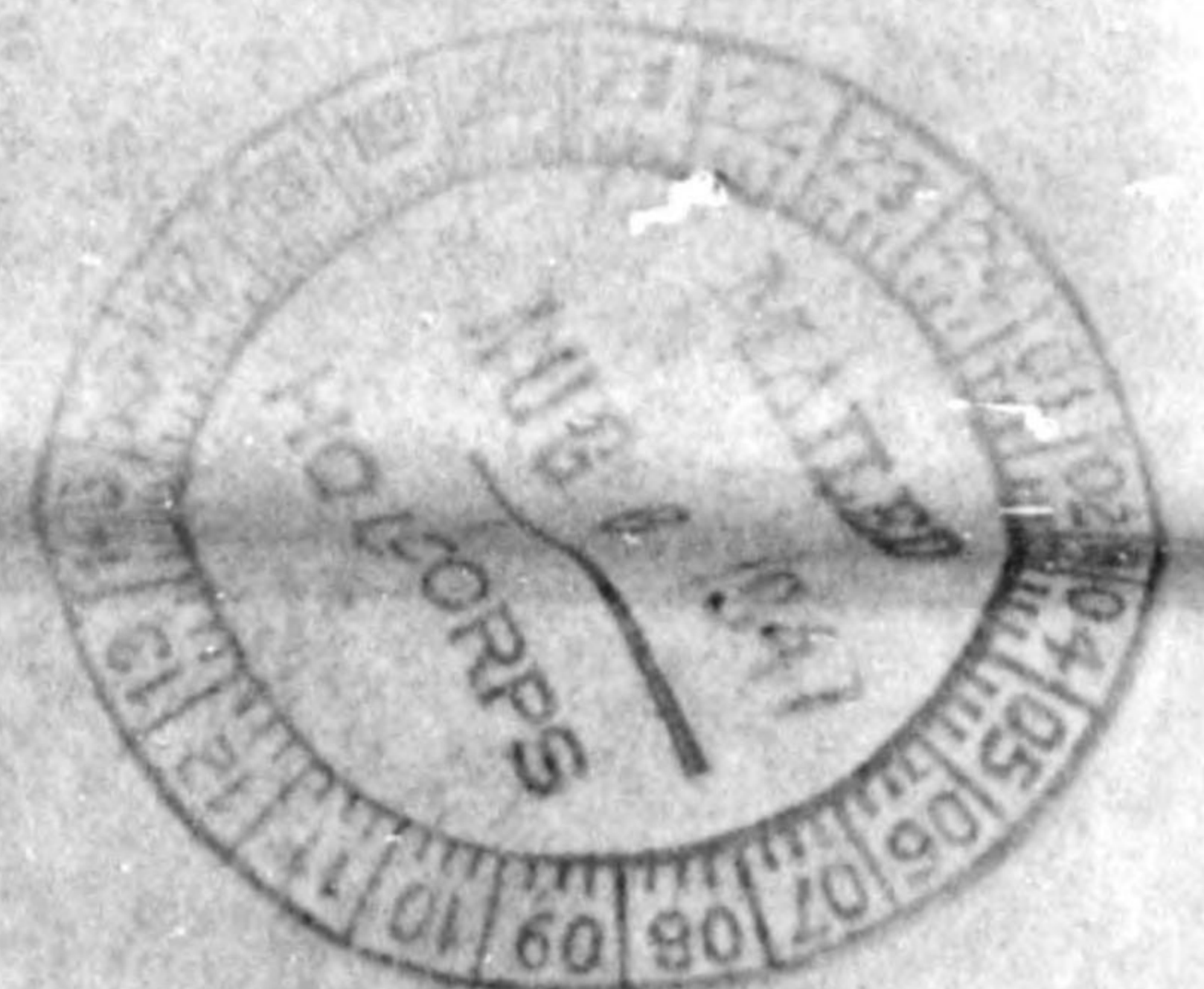

INVESTIGATION REPORT: The persons above listed were repatriated during February of this year.

1. Otto Schaefer did not own any real estate in Japan as far as Hyogo Prefecture is concerned. Evidence of this is attached as inclosure 1.

a. Home occupied by Schaefer at 249/13 Ueno, Imogadani, Nada-ku, Kobe was owned by one Karl Juccheim (deceased 14 August 1945) and passed on to Elise and Magarete Juccheim, repatriated in February 1947. Inclosure 2 shows Karl Juccheim to be the owner of the property.

Following action was taken as a result of investigation made in compliance with letter, your headquarters, subject as above, 27 May 1947:

a. Wakayama Liaison Office was requested to make investigation of the possibility of looted property being present in reparations factory in this prefecture. A previous investigation had been made by the Liaison Office which resulted in a negative report. Upon re-investigation, a similar negative report has been submitted to this headquarters.

b. The reparations officer of this team investigated reparations machinery by checking manufacturers' name plates on approximately 75% of the machines. All machines were manufactured in Japan with the exception of a 12,000 ton hydraulic press which was imported from the United States in 1941 by the Sumitomo (now Fuso) Metal Industries Ltd., Wakayama Iron Works Branch. The purchase of this press was handled by the Shibaura Kyodo Machine Tool Company and the importing agent was the Mitsui Bussan in Osaka. The agency in the United States which supplied this press was the United Engineering Company, address unknown.

c. From the foregoing, it is the opinion of this headquarters that there are no reparations machines in this prefecture which are looted property.

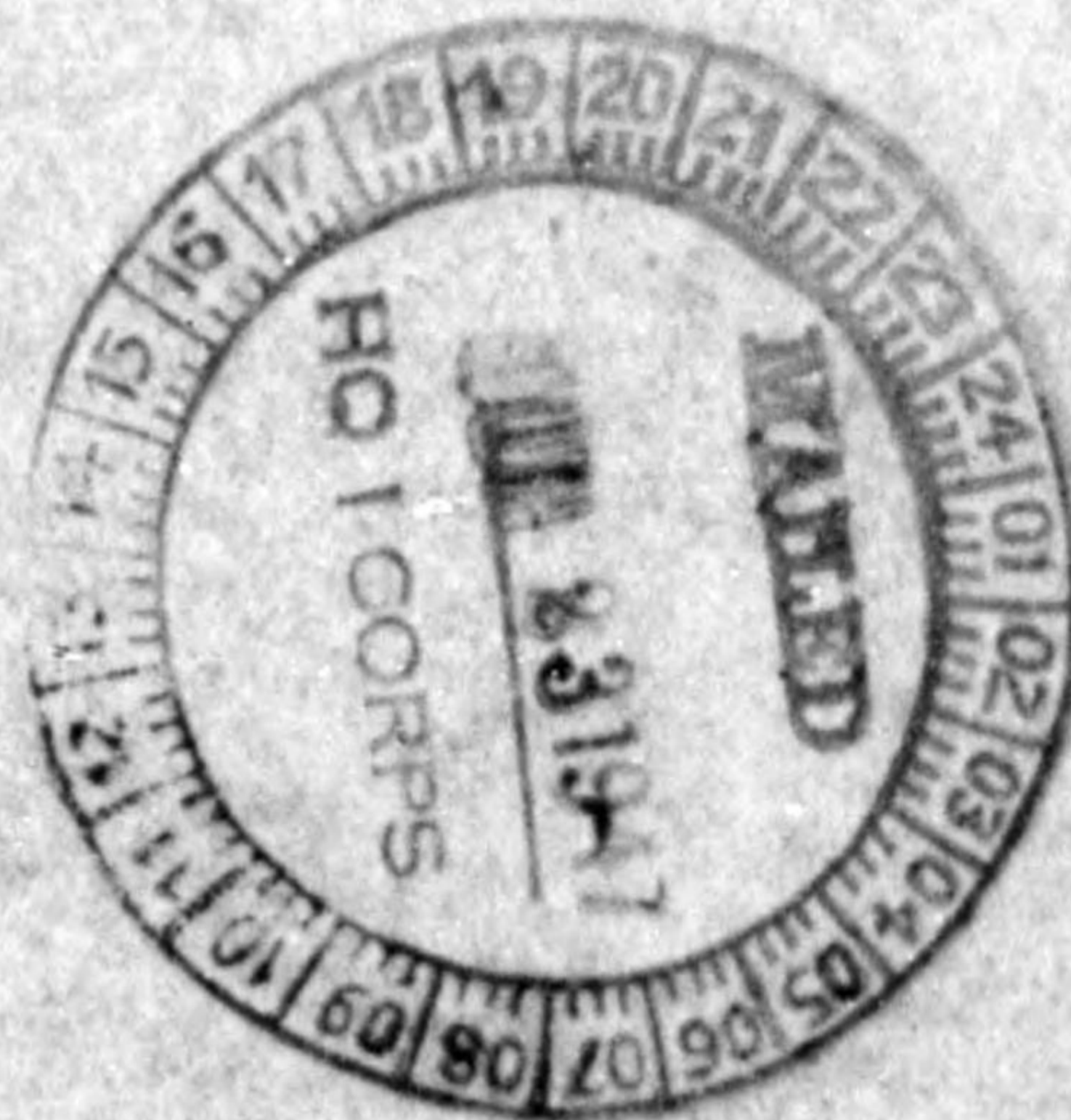
