

A BIBLIOGRAPHY OF STRIP-MINE RECLAMATION

During the past two decades much attention has been given to the problem of strip-mine reclamation. Federal, State, and private agencies have conducted many experiments designed to achieve greater success in the revegetation of lands stripped for coal. There now exists a small but important array of published material on strip-mine reclamation considered useful to practitioners and investigators. The purpose of this publication is to provide a list of references containing information that may be helpful in studying the problem. For convenience, the list is presented in two parts. Part I, A Selected Bibliography of Strip-Mine Reclamation, includes references pertaining directly to the subject; Part II, Additional References, includes a classified list of publications that may be helpful in the study of specific reclamation problems in the Central States but do not pertain directly to strip-mine reclamation.
