Rules for the Execution of the Anti-pertussis Inoculation

1. Frequency of inoculation

The regular preventive inoculation shall be executed at least four times annually.

2. Vaccine to be used

Pertussis vaccine which passed the assay under the Regulation on Manufacture and Assay of Biological Preparations (Ministry of Welfare Ordinance No. 8 of 1948) shall be used.

3. Means for storage of vaccine and period of effective use

The vaccine shall be kept at 2 to 5 degrees centigrade, and its period of effective use shall be 18 months from the date of passing assay.

- 4. Quantity, times and intervals of the inoculation
- (1) For those who take the initial immunization, the first injection of 1.0 ml, the second injection of 1.5 ml and the third injection of 1.5 ml shall be given subcutaneously at the interval of 3 to 4 weeks.
- (2) For those who take booster immunization, one injection of 1.0 ml shall be given subcutaneously.

5. General cautions to be exercised by those performing the inoculation

The inoculation shall be given politely, with special attention to avoid rudeness.

Even if in a hurry, the number of persons to be inoculated by one physician per hour shall be about 100.

6. Place for inoculation

The room for inoculation shall be clean, of

adequate space and with the proper ventilation and temperature, etc.

7. Preliminary examination

Prior to inoculation, a physical inspection and, if necessary, a physical examination shall be performed.

8. Contraindications

Inoculation shall not be given to those who are suffering from diseases such as severe congenital heart failure which may become worse by inoculation.

9. Disinfection of fingers

Those performing inoculation shall disinfect their fingers beforehand.

10. Disinfection of the instruments to be used for inoculation

The syringes and needles shall be disinfected by boiling water prior to use.

The disinfection of needles shall be done for each injection without fail.

11. The region of inoculation and its disinfection

The region of inoculation, ordinarily the lateral side of the upper arm, shall be disinfected sufficiently with tincture of iodine or alcohol.

12. Caution for handling of vaccine

Prior to each use, without fail, container of the vaccine shall be well shaken to make its turbidity homogeneous.

13. Cautions at the time of inoculation

When the point of needle is inserted into skin, a slight sucking shall be made to make sure that the needle is not in a blood vessel, and then the fixed quantity of the vaccine shall be injected.

It is recommended to massage throughly the region of inoculation after injection.

14. Accompanying reactions of the preventive inoculation

The injection sometimes will be accompanied with reddening, swelling, induration, pain of the region and fever, but they will disappear in a few days.

15. Concurrent inoculations

If convenient, other inoculations may be carried out simultaneously for the same person.
