DIRECT EXAMINATION OF YANO, Masao by Mr. Blakeney

The witness stated that he lived in Fukuoka. He iden23,272 tified Exhibit 2672 as his affidavit and verified it. \* The
affidavit stated that since November 1944 the witness served as
Chief of the Staff of the Third District Army under USHIROKU
and stayed in Tsitsihar until March 1945. He later became
commander of the 57th Army and went to Sanshinfu. On arriving
there he received an order from the Kwantung Army and was sent
with his division from Manchuria to Fukuoka to join in the Pacific
War. He helped draw up the plan of operations of the Third
District Army for the year 1945.

While he was not well acquainted with the plan of operations before 1945, he knew the outline of the plan was to defend against possible Soviet attacks, the right bank of the Amur River and the Hailar and Great Hsingan mountains in the west. When he arrived he received a new instruction regarding new operation plans from Kwantung Headquarters.

Under this the Third District Army was to gradually retreat after slight resistance in the Songo-Hailar area and was to make the final resistance on the Peian-Nonko-Jarantong-Hsingan line. The Army, therefore, drew up a concrete plan and when the plan was about to be reported to the commander of the Kwantung Army the witness was transferred. The Third District Army then had three divisions and one brigade. Only one division was well trained, the others being newly organized. The witness became commander of the well-trained division, but it was transferred to Japan Froper for the Facific War and a newly organized division was substituted for it. All divisions of the Third Army were therefore inferior in quality. When he arrived at Japan Froper, he learned that the Third District Army Headquarters was transferred to Mukden.

SWORN DEPOSITION

Deponent: Yano liesac

Having first duly sworn an oath as on attached sheet and in accordance with the procedure followed in my country I hereby depose as follows:

Def. Doc. 1155

I am an ex-Lieutenant General of the Japanese Army, and now living at No. 55 2 Chome Wagahamacho, Fukuoka.

Since November 1944 I served as the Chief of Staff of the Third District Army under General Ushiroku's command, and stayed in Titihar until March 1945. I subsequently became commander of the 57th Division and went to "Sanshinfu". Upon my arrival there I received an order from the Mantung Army and was transferred along with my division from Manchuria to Fukuoka for joining in the Pacific War.

I was connected with the drawing up of the plan of operations of the Third District Army for the year 1945 while I was the Chief of Staff of that Army. The circumstances are stated as follows:

Although I am not well acquainted with the plan of operations before 1945, I knew that the outline of the plan was to defend against possible attacks of the USSR, the line of the right bank of the Amour River in the north, and the line of Hairal and Great Hsingan mountains in the west. However, when I arrived there, I received a new instruction regarding new operation plans from the headquarters of the Kwantung Army. According to this, the Third District Army was to make gradual retreat after offering a slight resistance in the area of Songo and H Hairal, and was to make the final resistance on the line of Poian, Nonko, Jarantong and Hsingan. Following this instruction, the Third District Army drew up a concrete plan and when the plan was about to be reported to the Cormander-in-Chief of the Kwantung Armu, I was transferred.

At that time the Third District Army was composed of three divisions and one brigade. The divisions were the 57th, 107th and 119th, and only the 57th division was well seasoned, the others being newly organized inferior divisions.

I became the commender of this well seasoned 57th Division. However, this division was also transferred to Japan proper for the Pacific war. I newly organized division was substituted for it, thus rendering all divisions of the Third District Army inferior in quality.

After I arrived in Jepen proper, I was told that the headquarters of the Third District Army was transferred from Titihar to Mukuden.
