Teachers' Salaries and Allowances (Payment)

REGULATIONS, DATED 22ND JANUARY 1974, MADE BY THE DEPARTMENT OF EDUCATION AFTER CONSULTATION WITH THE DEPARTMENT OF FINANCE UNDER THE EDUCATION AND LIBRARIES (NORTHERN IRELAND) ORDER 1972.

The Department of Education in pursuance of the powers vested in it by Articles 57 and 125 of the Education and Libraries (Northern Ireland) Order 1972(a) (hereinafter referred to as the "Order") and of all other powers enabling it in that behalf, and after consultation with the Department of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Payment of Teachers' Salaries Regulations (Northern Ireland) 1974.
- (2) These Regulations shall be deemed to have come into operation on 1st October 1973.
- 2. The Payment of Teachers' Salaries Regulations (Northern Ireland) 1973(b) are hereby revoked.
 - 3. In these Regulations:—
 - "board" means an education and library board established under Article 3
 - "managers" shall have the meaning assigned to it under Article 2 of the Order:
 - "Salaries Regulations" means the Teachers' Salaries Regulations (Northern Ireland) 1973(c) or the Institutions of Further Education (Salaries and Allowances) Regulations (Northern Ireland) 1972 No. 2(d) or any Regulations superseding those Regulations.
- 4. Full-time teachers, including temporary teachers, and part-time teachers in voluntary grammar schools shall continue to be paid by the managers in accordance with the appropriate Salaries Regulations.
- 5. Part-time teachers employed by a board, including teachers so employed but not appointed to a grant-aided school or institution, shall be paid in accordance with the appropriate Salaries Regulations by the board by which they are employed.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

Article 57 of the Education and Libraries (Northern Ireland) Order 1972 requires the Department of Education to pay the salaries of teachers employed by education and library boards and of teachers employed by persons other than such boards except where Regulations otherwise provide. These Regulations provide that the salaries of teachers in voluntary grammar schools shall continue to be paid by the authorities of such schools and that part-time teachers shall be remunerated by the boards by which they are employed.
