STOCKS OF LEAF TOBACCO OWNED BY DEALERS AND MANUFACTURERS

JANUARY 1, 1942

Stocks of leaf tobacco owned by dealers and manufacturers in the United States and Puerto Rico on January 1, 1942, totaled 3,038,944,000 pounds compared with 2,939,036,000 pounds on January 1, 1941, an increase of 49,908,000 pounds. Between October 1, 1941 and January 1, 1942 total stocks increased 99,118,000 pounds compared with an increase of 272,126,000 pounds during the same period of the previous year.

Stocks of flue-cured tobacco on January 1, 1942, were 1,555,044,000 pounds as compared with 1,625,464,000 pounds on January 1, 1941. The stocks of Type 11 were reported as 572,284,000 pounds; Type 12, 561,845,000 pounds; Type 13, 290,751,000 pounds; and Type 14, 130,164,000 pounds on January 1, 1942.

Stocks of all types of fire-cured tobacco were reported as 160,512,000 pounds on January 1, 1942, compared with 122,250,000 pounds on January 1, 1941. Virginia fire-cured, Type 21, stocks were reported as 29,513,000 pounds; Type 22, 91,213,000 pounds; Type 23, 39,283,000 pounds; and Type 24, 503,000 pounds.

Burley stocks were nearly 66,660,000 pounds higher on January 1, 1942, than they were on January 1, 1941. The January 1, 1942, report shows 805,343,000 pounds. Maryland tobacco, Type 32, stocks were reported as 39,997,000 pounds on January 1, 1942.

One Sucker stocks on January 1, 1942, were 35,708,000 pounds; Green River, 32,346,000 pounds; Virginia sun-cured, 2,957,000 pounds; Eastern Ohio, 872,000 pounds; Perique, 945,000 pounds; Other Miscellaneous Domestic, 977,000 pounds; and Foreign-grown cigarette and smoking tobacco (Turkish and other) 90,621,000 pounds.

## JANUARY 1, 1942 CIGAR LEAF TOBACCO STOCKS

Stocks of American-grown cigar-filler types amounted to 154,962,000 pounds on January 1, 1942, an increase of about 8 million pounds over the stocks of January 1 a year ago. Type 41, Pennsylvania Seedleaf, stocks were reported as 85,382,000 pounds; Type 42, Gebhardt, 17,024,000 pounds; Type 43, Zimmer, 10,018,000 pounds; Type 44, Dutch, 6,435,000 pounds; Type 45, Georgia and Florida sun-grown, 2,044,000 pounds; and Type 46, Puerto Rican, 26,678,000 pounds in Continental United States. and 7,381,000 pounds on the Island.

The cigar-binder type stocks were over 7 million pounds higher on January 1, 1942, than they were January 1, 1941. Total binder type stocks were reported as 124,373,000 pounds. Type 51, Connecticut Broadleaf, stocks were 22,781,000 pounds; Type 52, Connecticut Havana Seed, 29,051,000 pounds; Type 53, New York and Pennsylvania Havana Seed, 2,434,000 pounds; Type 54, Southern Wisconsin, 32,706,000 pounds; and Type 55, Northern Wisconsin, 37,401,000 pounds.

Shade-grown wrapper type stocks were reported on January 1, 1942, as 14,976,000 pounds, which was 380,000 pounds less than the stocks on January 1, 1941. Connecticut Shade stocks were 10,225,000 pounds, and Georgia and Florida Shade 4,751,000 pounds.

The Foreign-grown cigar leaf tobacco stocks in the United States on January 1, 1942, consisted of 9,536,000 pounds of Cuba (Havana) tobacco, 5,913,000 pounds of Java and Sumatra, and 3,255,000 pounds of Philippine Islands (Manila) tobacco. The stocks of Sumatra and Java shown in the report do not include stocks owned by the Netherlands Indies Produce Corporation in the free trade zone and in transit.

The figures quoted for type totals are the sums of unstemmed and stemmed leaf as reported. A table is included showing stocks on a farm-sales weight basis with stemmed leaf converted to unstemmed equivalent, and also a table showing separately stocks owned by manufacturers and stocks owned by dealers. The detailed report shows all stocks subdivided according to groups recognized in the trade.

All figures quoted in tables are rounded to nearest thousand pounds.
