The confidential source [abroad] mentioned in this memorandum is CARLOS FELIPE BARRINAT GONZALEZ-POSADA, aka CARLOS BARRINAT, whose background is known to the Bureau. The letterhead memorandum has been classified confidential to protect BARRINAT, who furnishes information of Bureau interest on a continuing basis to the Madrid Office. No local dissemination was made of the letterhead memorandum.

The individuals on whom information is set forth in the letterhead memorandum were mentioned on page 3 of reference report of SA HAGY.

Information supplied by the subject concerning a letter dated 10-20-60 at Madrid, Spain, directed to RAMIRO VALDES by MARINA GARCIA, Cultural Attaché in the Cuban Embassy in Madrid (set forth on page 55 of reference report of SA HAGY), has been supplied in written form by the Madrid Office to Lt. Col. RICARDO AROZARENA GIRON, Internal Security Branch of the Information Section of the Spanish High General Staff, and to Mr. EDUARDO COMIN COLOMER, Technical Secretary of the Directorate General of Security, Madrid. They were also advised of the fact that subject was paroled on 6-6-61.

Two extra copies of this letter are attached for forwarding by the Bureau to the Miami and San Antonio Offices, together with copies of the letterhead and evaluation memoranda, for information purposes.
