America vs. Shigeru Sawada, Yusei Wako, Ryuhei Ckada and Sotojiro Tatsuta, which is a transcript of the record of the trial of the men responsible for the court-martial of the Doolittle flyers, SAWADA, Shigeru, states that the order for the court-martial of the flyers came from Imperial Headquarters and that at the time he left the Japanese 13th Army, the order was still at the Headquarters of the 13th Army.

#### MEMORANDUM RE: SAWADA, Shigeru

- I Subpoena subject of testimony The witness will testify regarding the policies, utterances and actions of the accused HATA during the time in which he is charged by the indictment. The testimony will tend to establish that the accused HATA took no part in any of the conspiracies charged to him and was not in anywise connected with the planning and initiating of wars of aggression.
- II Information from the Investigation Division The Investigation Division has forwarded the following information on the above witness:
  - From 1933 until 1938, he was Liaison Officer at Harbin in Manchuria, Military Attache to Greece, Poland and Rumania, and Division Commander in Northern Manchuria.
  - 2. In September, 1939, he was made Vice Chief of the General Staff.
  - 3. In December, 1940, he became Commander in Chief of the Central China Expeditionary Forces.
- III Examination of case file There is no case file on this witness.
- IV Cross-reference file on case file In File 00-264 appears a newspaper article which states that Lt. General SAWADA. Shigeru, was to
  be tried for the death of the Doolittle flyers and that he had made
  a sworn statement that the court-martial for the Doolittle flyers
  was ordered by the defendant TCJO.

The Investigation Division at my request traced the location of this so-called sworn statement to Volume III of the Public Trial of the United States of America vs. Shigeru Sawada, Yusei Wako, Ryuhei Ckada and Sotojiro Tatsuta. The statement concerning TCJO appears on page 2 of the second statement presented to the Court (page 213). Reference is also made therein to the defendant HATA. The pertinent portions of this statement are as follows:

- "Q. Why did you order these men to be tried by court martial instead of treating them as prisoners of war?
- A. There was an order from Tokyo.
- Q. Who gave you that order?
- A. From the War Ministry-General Tojo.

- Q. Did he give you that order in writing?
- A. In writing, yes.
- Q. Was that a letter sent from General Tojo to you?
- A. Tokyo Imperial Army Hq issued the order to all Japanese Armies at the front and General Hata gave me a written document stating to try these flyers that bombed Japan under this rule.
- Q. Did General Tojo order you to try the Doolittle Fliers?
- A. The Army under Nanking-under General Hata. General Hata is commanding chief of all China forces. He got the order from Tojo and re-issued it under his orders to me to try the fliers."
- V Evidentiary document card file in Document Division This source of material has not been investigated.
- VI Reference in evidence to witness or to the subject matter of his testimony -
  - 1. So far as I have been able to determine, this witness is not mentioned by name in the record.
  - 2. The subject of testimony of this witness is the same as that of the witness OKAMURA, Neiji, and is therefore very broad. The paper attached hereto will contain the record references which I have found to be pertinent up to the present time.
- VII Summary of testimony given This witness has not yet testified.
- VIII Decorations In the memorandum of 11 March 1947 it is revealed that the witness received the following decorations:
  - 1. 29 April 1940 Grand Cordon of the Order of the Rising Sun, recommended by the War Ministry for achievement in the Manchurian Incident.
  - 2. 29 April 1940 The Military Order of the Golden Kite.

    3rd Class, recommended by the War Ministry
    for achievement in the Manchurian Incident.
  - 3. 28 April 1943 Manchukuo decoration Ching Yuan-Chang, lst Class, recommended by the Foreign Ministry for achievement in the furtherance of Japanese-Manchurian amity.

- IX Non-listed investigation The analyses of recent IPS documents revealed the following:
  - IPS Document No. 2999. This is a bound file of the newspaper Tokyo Asahi for the month of July, 1940. They implicate the defendant HATA due to the fact that they relate to the period when he was War Minister. In Document No. 2999-B, it is stated the Army decided on a stiff course of action. This document is now being processed.
  - 2. Document Nos. 3001 to 3004. These are bound files of the newspaper Osaka Asahi for June and July of 1940 and the newspaper Tokyo Asahi for June 1940 and Myako Shimbun, Tokyo, for the month of July 1940. They implicate the defendant HATA as his resignation was responsible for the fall of the Yonai Cabinet on 17 July 1940, and state that the Army advocated a firm policy in dealing with China.

- 3. Please advise me of your opinion as to whether HARADA, Michie or HARADA, Mitsuo, mentioned in File No. 250-17-31, is the same person as the HARADA, Munakichi called as a witness for the defendant HATA.

SUBJECT : Witness - China Phase

In reference to your memorandum request of 30 April 1947, the following information is submitted:

- 1. A sworn statement by General Sawada has been located after a thorough search of our files in Vol. III of the Public Trial of United States of America vs. Shigeru Sawada, Yusei Wako, Ryuhei Okada, and Sotojiro Tatsuta, in evidence on page 213. The statement concerning Tojo appears on page two of the second statement presented to the court. The record of this trial is IPS Document #2972.
- 2. As the diary referred to in paragraph two of your request was compiled from the papers sent from units all over China to the War Ministry, it is impossible to say who wrote the book. However, it may be possible to find out the author of a specific portion of the diary, or at least the Translation Section would be able to identify the unit from which that certain portion was received.
- 3. Upon inquiry at the First Demobilization Bureau, I am quite confident that HARADA Mitsuo is not the same person as HARADA Kumakichi. It is improbable that one man would have two names and these first names are definitely two different names. Furthermore, as he was quite a prominent man, the former officers working at the First Demobilization Bureau would, in all probability, have heard of the name Mitsuo or Michio.
