1. The following report is based on information with SALZBURG Security Office.

2. Josefine SCHUSTER (data already known), who was so far employed with SALZBURG CP Landesleitung teletype station, has now been appointed member of Landesleitung by Hermann LANGBEIN. Probably she belongs to the Communist 'cadre division', which has to superintend Communist Party members in Land Salzburg. For such purpose she collaborates with the internal CP intelligence.

3. At VIENNA, a number of 14-day training courses for CP functionaries are being held from June 18 thru October 1e, 1951. At the end of July, the following SALZBURG functionaries were detached to such courses:

Matthias GRUBER, precision-tool maker, born September 30, 1922, at St. GILGEN, living at SALZBURG, 2, Kaiser Karlstrasse, AUSTRIA

Josef RÖSSLHUBER, data already known.

4. Hans BERGER, tactor, further data unknown, is regarded liaison man between CP Landesleitung and several cultural institutions at SALZBURG, especially the radio station. He collects intelligence on Salzburg cultural life. Allegedly he also tries to approach USFA personnel to elicit information from them. He frequently appears at SALZBURG CP Party Home to confer with Wilhelm BRANDECKER.

5. Rudolf HACKEL, who was repeatedly reported on as USIA and CP intelligence agent,

born June 24, 1923, at BRATISLAVA, protestant, unmarried, Volksdeutscher from CSR, nationality undefined, living at VIENNA I., 6, Marc Aurelstrasse,

a former actor, was active as salesman with several trade firms since 1945, when he came to VIENNA for the first time, because he could not find a job in his former profession. Since 1947, however, he occasionally took over small movie roles with 'Donau Film', 'Wien Film', 'Sascha Film' and others. Probably his activity for USIA and CP is not based on his personal political line, but on permanent want of money.

6. Both, Anna BUROVSKA, living at SALZBURG, further data unknown, and (fnu) RESKA, living at HALLEIN, further data unknown, have undergone a Party training in propaganda work and were charged with so far undefined special tasks.

7. Heinrich (Ernst?) MAIER, SALZBURG, 13/I, Getreidegasse, allegedly is doing photo work for Salzburg CP,

8. SALZBURG CP Landesleitung was informed by LINZ-Urfahr Landesleitung that confidential information on SALZBURG CP activities were passed on to CIC thru unknown channels. Such knowledge was brought to LINZ-Urfahr Landesleitung by a former woman teacher now employed with LINZ CIC (name unknown).

9. The Austrian Communist students use for propaganda purposes leaflets and booklets allegedly originating from the 'Büro der Internationalen Studentenvereinigung' (International Students Association Bureau) at PRAGUE. One of the chairmen of such Association is Ernst WÖRTZ,

born October 11, 1930, at VIENNA, living at VIENNA XXI. 44, Konstanziagasse, student of political science, at Vienna University; occ

another activist with International Students Association is the young physician (Dr) Friedrich GANTZ, chairman of the Communist-controlled Medical Students Association ('Arbeitsgemeinschaft der Mediziner').

10. Karl ZAHRL,

occ waiter, born August 15, 1910, at SALZBURG, Austrian citizen, married, residing at SALZBURG, 22, Dr. Petterstrasse,

is believed to work for Soviet intelligence. A former officer with German Wehrmacht, ZAHRL was sentenced to death. He succeeded in fleeing, and, according to his own statement, became major with Yugoslavian partisans. About 3 weeks ago he made a trip to CSR, and will go to BUDAPEST in the near future. Purpose of these trips is unknown. He holds close connection with former Kriminalrevierinspektor Franz THALHAMMER, known as Communist.

I, Klaus Berger, do hereby acknowledge that I have this date received the sum of DM 5,553.00 (five thousand, five hundred, fifty-three Deutsche Marks) from the Government of the United States of America. In accordance with the agreement under which these funds were entrusted to me, I have purchased with these funds on behalf of the United States Government one Volkswagen Export, motor number 1-0 444 221, license number B 55-4697, Kraftfahrzeugbrief No. 1903591.

In consideration for the delivery of these funds to me and for the granting of this vehicle into my custody and in consideration for such other benefits as I have received or shall receive from the Government of the United States, its Agencies or representatives, I do hereby agree as follows.

It is understood and agreed that this vehicle, although officially registered in my name, is now and will remain the sole property of the United States Government; and that it is to be held by me subject to the direction of the United States Government or its authorized representatives and that I have no personal proprietary interest in or claim upon this vehicle; and that in the event of my death or disappearance, or at such other time as the United States Government or its authorized representatives shall designate at its discretion, this vehicle shall be returned into the possession of the United States Government, and that neither I, nor my estate, nor my heirs, shall have any claim upon it.

1. BERGER, Hans, born 5 October 1911 in STERNBERG bei OLMUTZ, now Czechoslovakia. He is about 5' 8" tall, of slender build, blond hair, blue eyes. He currently resides at SICHARTING Number 84, Land Upper Austria, and is employed as storekeeper with a construction firm. He was at one time employed in the painting and decorating of ceramics, porcelain, and glass. He served in the "German Intelligence Service" during the war, according to ZIFFER. (NOTE: Primer possibilities, both firm, are "Ortsgruppenleiter Hungary in touch with SD, 1943", and "Unterstaermafuehrer, Sudeten-deutscher, born about 1906, Sipo and SD Einsatzkommando Yugoslavia since 1940; wife Yugoslavian". We note also that the British issued a final interrogation report, number FR-66 dated 5 April 1946, on one Major d. Bez. Hans Harold BERGER (we have a file trace reference to this report, but never have held the report), which might be identical.

2. SKODA, Franz, born about 1925, residing WIEN XII, Northenburgerasse 2/III/7. He served as a watchman with the Wiener Sicherheitswache 1945 to 1952, is currently unemployed. He has allegedly had no intelligence experience.

1. Frankfurt files contain the following possible traces on subject:

a. Dropped Agent's File, dated 1 December 1948, lists Hans BERGER, born 5 August 1912, residence BAD TONIZ; dropped for ineptitude.

b. Reference is made to I.D. KOCCH's letter, dated 16 August 1951, MGHA-11760, subject Albert HOFFMAN, alias ~~fm~~ BERGER.

A check of WDA 0-2 files revealed the following: 0-2 file card refers to the arrest of a Hans ~~XXXXX~~ at Lodz, in June 1945 by Adolf CIC, but there is no reference to interrogation and release or other disposition. This ~~XXXXX~~ was born 5 October 1911, was ex-cc. interned, an advertising draftsman, and "intelligence of foreign matters" (connection not specified on the card). He was with the SS & SA in Hungary, with SA in Jugoslavia in 1940, in cross-country in 1939, in Yugoslavia in 1941, and in Vienna from Oct 1941 to April 1945.

2. 0-2 files, 1 cc/SSM/23 29, Interrogation of German SS/XXXX-XXXX, 8-16 Aug 45, source stated that ~~XXXXX~~ Hans KAMMER had been in Gruppe VI/5 of the SS in Vienna since Sept. 1944. KAMMER was previously deputy leader of the VI, SS Belgrade, and before April 1941 an employee of the Deutsche Fremdenverkehrsamt at Belgrade. He was a Sudeten German, about 30 years old, married, had two children.

3. 0-2 files, cc. officials' list containing a Hans BUNDE, born 5 October 1911 in Albstadt/Donau. This BUNDE (serial No. 301733) obtained the rank of Uffz. on 9 November 1942.

4. 0-2 file card (no document) may refer to the same document, FN 65, mentioned in WDA 3519. This card lists a Major King HAROLD SMITH who was with the CIC, Air VI Bomber Unit, Innsbruck, and was arrested by Polish 13 September 1945. A date on the card, presumably SMITH's birthday, is 20 March 1900.

5. A check of GDB and Salzburg CIC files revealed no traces.

1. Enclosed are ZIPPER memos 5876, 6051, 6118, 6122, 6167 and 6168 giving the recent developments in subject case.

2. Memo 5876 describes UM's plans for the inclusion of V-14509 in subject case. V-14509's suggested tasks were to be the following:

- a. The spotting of successors and/or sub-sources for ADLER.
- b. Acquiring build-up material for ADLER's use.
- c. Looking for a suitable job for ADLER. (As V-14509 would be stationed in the Munich area, the job would probably not be near Heidelberg but a solution would be for ADLER to be employed as a travelling salesman for a firm which would enable him to cover his old territory in Heidelberg and vicinity.)

UM plans to have V-14509 reporting only to him and will not divulge any information on subject case to him. On the other hand any suitable sub-sources and/or successors will be played onto ADLER so that the latter will not be aware that they are controlled by ZIPPER. The latter measure will insure ADLER's safety when the latter is face to face with KATZEL interrogators. Such an operational scheme would be a neat trick but we are of the impression that V-14509 will become aware of exactly what kind of an operation he is involved in. In order for UM to get good results from V-14509, he will have to give him explicit instructions as to exactly what type of people he is looking for. Such prerequisites as anti-Communist, access to Allied military installations, psychologically stable, etc. can only indicate a DA operation to anyone at all familiar with "the business" and V-14509 has had past intelligence experience (see ECLA-3519). Of course, if UM had the time he could omit the requirement of access to Allied military installations and hope that by chance such a type

would agree to the fact of being anti-communist, so that they could be  
spotted by V-14509. However, with this in mind it would be necessary to request,  
it does not seem that there will be time for this. The possibility of a play  
in itself on V-14509's part would not endanger the case itself so long as V-14509  
does not learn the identity of ADLER. The above proposals of G-1 were part of  
a request also made to HQ with reference to the G-1 and G-2/D-10 interview  
to get HQ Headquarters to take a stand on the future of the ADLER case. Our  
aim was to get G-1 to perform all of the spotting and subsequent controlling  
of ADLER's successors and/or sub-sources thus preventing an unnecessary extension  
of ADLER's CP organization into West Germany; to get HQ to agree that V-14509 should  
not undertake any activities involving the gathering of "Spielematerial" for ADLER  
to hear HQ's reasoning on the question of a further build-up of ADLER vs. his im-  
mediate return to Hungary. The ZITTEL stand was roughly that the immediate return  
of ADLER to Hungary would be tantamount to throwing away a possible turn in the case  
which could develop should ADLER be able to report on any qualified sub-sources  
and/or successors to the ZITTEL. ZITTEL feels that due to ADLER's experience in  
Germany plus his radio training that the possibility definitely exists for him to  
get an assignment as chief agent or radio operator for a net. Should the sub-  
sources consist of those which ADLER has spotted, ZITTEL would have another control  
on the operation through G-1. The logical extension of this possibility is to  
let ADLER remain in West Germany until the ZITTEL reacts to his presenting several  
qualified sub-sources and/or successors. ZITTEL agreed, however, to call in G-1  
on the spotting of ADLER sub-sources and/or successors and to assign the control  
of any future sub-sources and/or successors to them. V-14509 will continue to run  
ADLER due to the feeling of mutual trust which has been developed between the case  
office and agent. Due to the lack of Hungarian experts in G-1, UN will be  
called in as an advisor on theory problems evolving from operations which might  
possibly develop from ADLER sub-sources and/or successors and also will serve in a  
logistical support function, i.e. travel through Austria, for any such operations.  
Due to the immediacy of ADLER's possible return to Hungary, ZITTEL felt that  
V-14509 should also perform the spotting function for ADLER as outlined by UN, but  
agreed that V-14509 would not undertake to gather any "Spielematerial" for ADLER  
and that any personalities spotted by him would ultimately be controlled by G-1.  
Thus, we achieved our immediate aims and gave our tacit approval to ADLER's re-  
maining in West Germany at least until we see the ZITTEL reaction after he has  
reported on any sub-sources and/or successors.

3. Memo 6051 presents G-1's plan to have UN transmit his information  
on Egon FUCHSBERG and Joseph W. G. with a recommendation as to intelligence val-  
ability. After clearance by Headquarters, UN planned to pass this material on to  
the ZITTEL and then, via external surveillance, determine if either of them were  
approached by the ZITTEL subsequently approaching them for organization control  
purposes. We need not belabor the impossibility of this technique but only  
mention that ZITTEL Headquarters, in the meeting described in para 2 above,  
favored having the above two individuals investigated and, if the latter is favor-  
able, controlled by G-1 prior to the receipt of any recommendations or detailed  
summary of personality by the ZITTEL.

4. ADLER notified his contacts in Vienna on 1.7.53. ADLER reported that he had posted letter reports 1/10 and 11/1 to KATPOL cover addresses in Budapest on 22.6.53 and 30.6.53 respectively. In report 1/10 ADLER gave the latest bits of information regarding his contacts. In report 11/1 ADLER gave a written explanation of the new BLD's and the Ludwigshafen station and requested that the KATPOL messages be sent an hour or so later during the summer months. ADLER further reported that he had been able to receive KATPOL message 26/53, but that he had difficulty with 27/53 and was only able to reconstruct the meaning having put all the clearly receivable pieces together. ADLER further stated that he had deposited reports (material already cleared by us) in BLD "Musik" on 10.6.53. From the context of 27/53 ADLER interpreted that the KATPOL had placed asterisk 1 in the BLD; therefore visited it on 28.6.53 and found money, his birth certificate and rubber stamps, plus new instructions from the KATPOL. ADLER also stated that he had been forced by the "Arbeitsamt" to advertise in their magazine for a job as an airplane technician, driver or office helper. ADLER was instructed by his case officer to acknowledge the receipt of the KATPOL material found in the BLD and to study his new BLDs for a discussion at the next meeting (see memo 6118).

5. Memo 6122 reports on the KATPOL deposit in the BLD. ADLER found a hollow key which contained his new BLDs filed on very thin paper, two birth certificate blanks, three rubber stamps to make the birth certificate official and \$400 plus 200 Austrian schillings. The serial numbers of the \$ notes were as follows: \$10 notes, D74823820B, C97847457D, E56299939F, E54326672F; \$20 notes, K16475804, K10827121A, A07621721A, K17976707A, H00872024\*, E09418406A, K18200491A, D07702548B; \$100 notes, B10068592A, K11307965A. ADLER received the following instructions:

a. To continue looking for a full-time job regardless of the possibility of his being employed in the German Aircraft Industry. Moreover, he was requested to continue reporting in details on his own personal situation.

b. ADLER was encouraged towards more exact and detailed reporting. Some gross inaccuracies in his past reports were cited and he was instructed to follow up leads obtained from the "Stars and Stripes" and to use adjectives such as unconfirmed for any information about which he was <sup>not</sup> absolutely positive.

c. ADLER was further urged to continue his sporadic activities to as great an extent as possible.

d. The KATPOL also informed ADLER that they wanted him to return to Hungary for about five days in August. They gave him detailed instructions as to how to get to the Soviet Zone of Austria with the documents available to him.

You will note that many of the BLDs given ADLER are far above his present capabilities. He would need possibly unwitting but probably using inside sources to be able to determine the organizational structure of the "Bundesgrenzschutz" in Munich and of U.S. technical and communications units.

6. Memo 6187 contains ADLER's answer to our query as mentioned in para 4 of ref.

7. ADLER again met his case officer in Munich on 6.7.53. ADLER reported that he had not been able to receive the KATPOL special message announced for 2 and 3.7.53 but that he was able to receive and decode KATPOL 28/53. ADLER stated that he had sent report II/2 to a KATPOL cover address in Budapest on 6.7.53. In this report ADLER acknowledged the receipt of the material found in the GLD on 28.6.53 and transmitted "Spielesterial #3" (see HOLA-4396). ADLER also presented V-14111 with a detailed report on Leon FOCKMANN. V-14111 instructed ADLER to report to the KATPOL in detail on his personal situation and to list his past efforts to successfully legalize himself. Moreover, ADLER was instructed to follow up and investigate leads appearing in the "Stars and Stripes" if they pertain to the Heidelberg-Karlsruhe-Mannheim area. V-14111 also instructed ADLER to carry out only those HNs, with the time limit of 31.7.53 (see memo 6122), which could be fulfilled by external observation. ADLER declared himself ready to return to Hungary and stated that he had completed his forging of a birth certificate and would soon request a "Heinepass" (see memo 6168).

HYDROLOGY #16 - Operation STANKO

Reference: FOI-A-6170

1. Subject of reference had been assigned the cover name STANKO by SIPPER.
2. On 22 September V-14509 met with STANKO in MUNICH at which time STANKO agreed to accept the offer to work in the intelligence field with V-14509. STANKO was to commence work on 1 October.
3. STANKO has been legalized as a refugee in Western Germany and is moving to MUNICH. His first assignment will be to prepare a report about the Bulgarian emigration. STANKO commented to V-14509 that he intended to take up contact with Todor DAMJANOV currently employed in NSZ MUNICH and formerly worked with STANKO in SALZBURG. STANKO also spoke of intelligence possibilities he could offer via the Bulgarian refugee in Trieste, but would not reveal the name of this refugee. STANKO again interested himself in the exact identity of the organization V-14509 represented and was told that it was an American organization which made a practice of keeping in the background in the interest of security.
4. On 23 October, shortly after a pre-arranged meeting between STANKO and V-14509 had commenced in a MUNICH cafe, a member of the German Criminal Police approached V-14509 and demanded his identity documents. Accompanying him were two Americans, clearly CIC agents. Although V-14509 managed to get far enough away from STANKO so that STANKO could not see his identity documents, the Criminal Police type addressed V-14509 by true name and it is certain that STANKO overheard it. V-14509 demanded that the CIC officials take him to their office and there gave them his emergency number. He was promptly released but there is nothing we can do to prevent CIC from revealing to STANKO that V-14509 is a member of SIPPER except hope that CIC has not and will not do this. V-14509 managed to get STANKO to confess that he had arranged this arrest in order to learn V-14509's identity. STANKO has been told that this may result in his dismissal and definitely will result in a reduction of his salary. He has been paid only half his salary for this month and told he will receive the rest only in return for outstanding work.

5. For NS and GOW: Attached (one copy each) is GOW report number 11009 concerning the recruitment of STANKO by V-14509 and GOW memo 11008 announcing the assignment of cover name.

1) "STANKO" hatte von Anfang an versucht, Näheres über die Person und Org. seines VK-Führers 14 509 in Erfahrung zu bringen. Er motivierte dies stets mit der Erklärung, dass er bzgl. der Echtheit des 14 509 sicher gehen wolle.

2) V-14 509 hatte für 23.10.53, 1400 h, einen Treff mit "STANKO" in MÜNCHEN, Stieglmayerplatz, Löwenbräu-gaststätten, vereinbart. Unmittelbar nach dem Erscheinen "STANKO,S" kamen drei Männer zum Tisch. Einer derselben wandte sich sofort an 14 509, wies sich als Angehöriger der Kriminalpolizei aus und erklärte, dass er die Identität des 14 509 festzustellen habe. 14 509 erklärte, er sei dazu bereit, jedoch rief er zu einem anderen Tisch. Er wies auch an einem anderen Tisch (also von "STANKO" entfernt) seinen Pass. vor, verweigerte aber die Beantwortung weiterer Fragen bzgl. Wohnort und Tätigkeit. Er sei jedoch bereit, mitzukommen.

14 509 vereinbarte mit "STANKO" eine neuerliche Zusammenkunft für 1600 h und verliess mit den drei Beamten das Lokal. Sie fuhren mit einem PKW zum Polizeipräsidium in der Sttstrasse, wo der Kriminalbeamte ausstieg.

Als die beiden im PKW verbliebenen Männer erklärten, CIC-Angehörige zu sein, verlangte 14 509 zu ihrer Dienststelle gebracht zu werden. Daraufhin ging die Fahrt zum Camp "Peterson" in MÜNCHEN. 14 509 gab dort seine Notnummer an und wurde dann nach Überprüfung der Sache nach etwa eineinhalb Stunden wieder zum Stieglmayerplatz zurückgebracht.

3) "STANKO" war bei der Abhandlung überhaupt nicht befragt worden, musste sich auch nicht legitimieren und blieb bei der Abfahrt des 14 509 im Lokal zurück. Es stand also fest, dass der Vorfall von ihm veranlasst wurde.



4) Nach der Rückkehr vom CIC traf 14 509 "STANKO" wieder in dem Gastlokal. 14 509 stellte ihm sofort zur Rede und sagte ihm auf den Kopf zu, den Zwischenfall veranlasst zu haben, was "STANKO" anfänglich leugnete, später aber indirekt zugab. Er verantwortete sich damit, dass er nicht wieder in eine Falle gehen wollte.

Als 14 509 darlegte, dass unter diesen Umständen die weitere Mitarbeit "STANKO,S" sehr in Frage gestellt sei, versuchte dieser zu erklären, dass er aus einer Zwangslage heraus gehandelt habe, und versprach, seinen Fehler durch gute Arbeit wieder gutzumachen.

14 509 liess die Frage der weiteren Mitarbeit "STANKO,S" offen und sagte ihm, dass er ihm diesbzgl. beim nächsten Treff Bescheid geben werde.

#### STELLUNGNAHME 14 509:

- 1) Es steht einwandfrei fest, dass "STANKO" den Zwischenfall veranlasst hat. Der Grund hierfür dürfte weniger die Angst, für eine gegnerische Stelle zu arbeiten, sondern vielmehr die Absicht, Näheres über seine vorgesetzte Stelle in Erfahrung zu bringen, gewesen sein.
- 2) Es muss damit gerechnet werden, dass "STANKO" möglicherweise seine nun angeknüpften Beziehungen zum CIC oder MIS MÜNCHEN auch weiterhin aufrecht erhalten wird.
- 3) Als Repressalie im Falle einer Weiterverwendung "STANKO,S" schlägt 14 509 eine Kürzung der monatlichen Zuwendung vor.

#### STELLUNGNAHME U/M:

- 1) "STANKO,S" Monatsgehalt wurde um M 50.- herabgesetzt, überdies wird das Gehalt in Zukunft in zwei Raten ausbezahlt.

1. Forwarded for the record is a copy of the original U/M report of the detention of V-14509, mentioned in reference.

2. We agree with U/M that © STANKO arranged for the detention of V-14509 by CIC. His motive may have been honest fear that V-14509 - who refused to identify the organization he represented, beyond saying that it was a "western" service - might be an enemy agent, but in view of the extreme doubts of © STANKO's loyalty which we entertain - impelling ZIPPER to recruit him as an aspect of UJDROLLERY-16 - © STANKO's motive may not have been so lily-white. We cherish a faint hope (which previous experience does not justify) that CIC will refrain from telling © STANKO that V-14509 is a ZIPPERite, but U/M has agreed that this will not be an unmitigated catastrophe, though certainly not the best of all possible situations. We have not asked CIC what they told © STANKO, nor have we explained our true motives in recruiting him.

3. In this connection, U/M informs us that V-14501, after searching his memory at our request, has recalled that V-14530 is aware that he is currently working for "TIB", and we presume V-14530 has duly reported this to the SRIS. V-14530 determined this through another nice assist by CIC: at the time ZIPPER recruited V-14530, inquiries about him were addressed to CIC, and "Mr. BROWN" learned that "TIB" had recruited V-14530. According to V-14501 (via U/M), shortly after V-14530 was recruited, he told V-14501 that © STANKO had informed him he (© STANKO) had learned that V-14530 was now working for "TIB MUNICH". Somehow, we do not regard this contretemps as catastrophic, either, as we felt from the outset of UJDROLLERY-16 that the SRIS had probably sorted out the unit with which V-14530 was associated by the simple process of elimination, CIC being rather readily excluded. (The proposal to abduct V-14501 pointed strongly to the theory that the SRIS was aware V-14501 was not an American.) In view of our conclusion, we pressed U/M to examine this idea, with the result given above.

A Headquarters file note dated 1 April 1952 states that case suspended as Subject employed by KUGGON. KUGGON files indicate that Subject was of interest in 1950 as he was a secretary in the Statistics Office, Praha-Karlin. About 24 years old, 5'9", 180 lbs, blonde curly hair, blue eyes. KSC member since 1946 (Source - CSL-O-133). Another reference, CSL-O-132, states that Subject has several functions in the KSC, one of them being instructor in Marx-Leninism. He can provide information on the Central Committee of the KSC in Prague as well as on other KSC meetings. Contact established via his sister who is wife of an imprisoned member of OKAPI 15's Valachia organization.

1. Following is the only likely trace we could find here on GRUBER:

DCE-258, dated April 1950, a report on the activities of Ilija ("Monty") Radulovich, a professional spy who worked for both German and British IS at various times, mentions that Mr. Radulovich was once found "in conference with Walter GRUBER, later 'Sonderfuehrer' in the German Administration in Belgrade."

2. We could find no likely traces here on Alois KRANICH.

3. There are over 150 traces here on various persons named Hans MUELLER. We have reviewed a number of these which contain report on persons named Hans MUELLER who are suspected Soviet or Communist agents in West Germany, Berlin, and the DDR, not to mention others who are or were active or suspected Communists in Austria. None of these seems to refer definitely to the individual described in reference. Should further background data on the Hans MUELLER of EGLA-6092 be obtained, we shall recheck the files here and forward whatever further data seems pertinent. Following seems to be the most pertinent traces which we could find here for the time being:

1. V-14509: Personal acquaintance of U/M, recruited to augment the U/M CE staff. His primary mission was to be the support and development of the ADLER case (UJ-DRO MUMI 300), and he has sought potential sources for this case in Western Germany, and succeeded in finding one - as in STANKO case, it was hoped, could be inserted into the case as sub-source, whose cooperation with "ADLER" would be monitored by a U/M contact. (See EGIA-7799). V-14509 was briefly committed in VIENNA when first recruited, to attempt the recruitment of a person known to him who made trips to Eastern European states, but the attempt came to nothing because of the financial demands of the man concerned - whose identity we do not know. Then V-14509 was moved to West Germany, and assigned to recruit and operate "STANKO", the Bulgarian friend of V-14509. "STANKO" was dropped by CIC Austria in August 1953, and moved to Germany for disposal. The development of UJ-DRO MUMI 16 made it appear quite likely that "STANKO" either had been recruited, or was about to be recruited by the SAU, and U/M therefore felt it worthwhile to take up contact with "STANKO". Nothing positive has emerged from this contact, with the exception of a minor catastrophe when "STANKO" arranged with CIC MUNICH, with whom he had been given contact when he was moved from Austria, to arrest V-14509 and determine for whom he worked. This maneuver appears to have succeeded, insofar as we can judge from reports made by "STANKO". U/M plans to send V-14509 to VIENNA soon, for duties which he has not yet made clear to us. "STANKO" will either be turned over to another U/M type, or abandoned.

V-11 801 Since the last report of this nature V-11 801 was transferred to Vienna where he is to work in the legal transfer field. It was intended that he would be an independent operative with only occasional meetings with V-11 802. His main mode of communications was to be through mail drops. This was put into effect but we do not know how far the arrest of V-11 801 went toward compromising V-11 809 to the Austrian police. At the time of his transfer to Vienna ZITNER attempted to have us work out a financial cover arrangement for V-11 809. The scheme involved the sending of money from the US to Switzerland and the forwarding of the money to Vienna. The purpose of this was to make V-11 809 last headquarters in Vienna where he was to practice his profession. He is a graphic artist. He rejected the proposition both on the grounds of it being too complicated and the fact that V-11 809 had previously exposed himself as an intelligence operative.

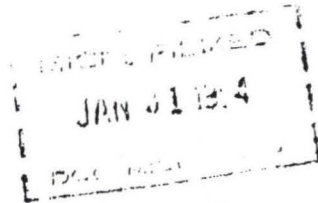
