Siren:

The following is a report of a U.F.O. sighted at a point approximately 40 miles NNW of Dubuque Iowa, 100 miles S of Lacroix Wis., and 90 miles ESE of Madison Wis., near the town of Cassville, Wis.

Thursday, 9 Nov. 61, this object was spotted at 1805 hours traveling a course approximately NW to SE. It was described in shape by two eye-witnesses, (both sane and sober), as rocket shaped or the shape of an old fashioned lamp chimney.

It was observed moving in a SE direction for 15 minutes, changed course to NW for 10 minutes, then changed to N. It continued this direction for 20 minutes. At the end of this time it stopped and was observed motionless for another 20 minutes, from 1850 to 1910 hours. During this motionless period, a beam similar to a floodlight pivoted around the object at least twice. The object was lost from sight in a 4 minute period while another witness was being summoned.

Due to the fact that there was no object for comparison in the sky at the time (discounting stars) the size and altitude could not be estimated, but were thought to be comparable to a jet.

The mode of propulsion is as described; the speed varied from a complete halt to estimated speed of a jet, with speed increase accompanied by a shower of "sparks". At the time of movement, the object glowed with the intensity of a star, but upon slowing and stopping, the light dimmed to the point of being barely discernible. Also at times the shower of sparks came without any visible movement. At these times, the light increased without movement.

Counting all times the "spark" phenomenon was seen (with and without movement), the estimated number of times it occurred is 75-100. The altitude seemed to change with change of course, but not in a systematic manner.

At this same point, approximately 5 weeks ago, another sighting was made. This object was traveling on a straight course from ESE to WNW. I was an observer of this and the following are my own estimates;

The object appeared to be at between 50,000 to 60,000 feet (based on the fact that a conventional motor aircraft was traveling over at the same time at an estimated 12,000-15,000 feet), at a speed of well above 2,000 MPH. (How far above I hesitate to say but because it sounds ridiculous but I placed it at 6 to 8,000 MPH). It had a steady, yellowish-white glow.
