Subject is a graduate of the Military Academy in Wiener-Neustadt. In World War I he was a battery commander in the Austrian Army. From 1920 to 1937 he served in the Rumanian army. From 1938 to 1942 he worked for a cement factory in Siebenbuergen. In 1942 he was drafted into the Waffen-SS and sent to the Balkans. He was a prisoner of war of the Americans from 1942 to 1945. After his release he became a night-watchman for the PERR firm in Salzburg. Since June of 1951, Subject has been employed as a bookkeeper with an American Office in Salzburg.

2. Subject may be identical with the Hans ENDERLER mentioned in the German Primer.

3. For Salzburg: Will you please endeavor to find out for which office Subject is working and if his job is sensitive in nature.

1. A check of GSB files revealed no traces on Subject.
2. A check of USFA G/CEC files revealed traces on one Hans KEDERL, former Lt. Col. in German Army, in S-18737, dtd 31 July 53. His address is given as Innsbrucker Bundesstrasse 7/1, and he is listed as an informant of Petri CONSTANTINESCU alias BOGDAN.
3. G2 card file lists one Hans KEDERL, born 27 Apr 1888, scars on shin and tattoo left upper arm, Obersturmannführer in Waffen SS, as having been arrested by Lt. CEC on 19 May 1946.
4. A check of Salzburg Labor Office files revealed that Hans KEDERL, born 27 Apr 1888, received clearance to work for USFA Engineers on 4 June 1951 and is still so employed, at a gross monthly wage of 1561 ANG.

1. In January 1954, ZIPPER requested traces on a Hans ENDEL living at Innsbrucker Bundesstrasse 7/1. (EGLE-6968) A reply to this trace request, WAAA-3066, mentioned that ENDEL was known as an informant of CONSTANTINESCU's. This information was passed to ZIPPER and we received the following reply from them:

Peter Stefan CONSTANTINESCU & Peter BOHRAN, born 29 September 1910 in Iasiu, Roumania, lives with his friend Maria GRABOWIECKI and her brother Hans ENDEL at Innsbrucker (Bundes) Strasse 7(1). Maria GRABOWIECKI nee ENDEL, born 8 December 1905 in Ierna Vatra, Roumania, is a widow employed by the banking house Carl SPANNLER & Co. of Salzburg. She is the secretary for and on the executive committee of the "Vereinigung der Rumunen in Oesterreich".

2. ZIPPER had stated to us that they intend to use ENDEL as a letter drop and/or as an accommodation address, but they now inform us that ENDEL is no longer considered for use. The above is for your information.
