

1. Authority: Ltr, GHQ, SCAF, file AG 014.33 (5 Mar 49)GA, dated 7 April 1949, subject: "Repatriation of Korean Nationals".


2. GHQ, SCAF has approved the application for repatriation to Korea of the Korean Nationals listed in attached inclosure. The number of dependents authorized for repatriation is listed opposite the head of each family in the inclosure.

3. The Korean nationals are being informed of the approval of their applications by the Japanese Government. They are also being instructed that travel to Sasebo will be at their own expense and that travel from Sasebo to Korea may be made on Shipping Control Authority Japanese Merchant Marine repatriation vessels returning illegal Korean entrants to Korea.

4. Subject repatriates must report for repatriation shipping within ninety days of the date listed on the inclosure.

5. Korean repatriates are to be permitted to convert Japanese yen for Korean won not to exceed ¥100,000 per individual. Authorized accompanied baggage will not exceed 4,000 pounds per family unit to household.

Upon arrival at Maizuru, one of the guards suspected Murakami of being a Chinese. Further investigation revealed a Chinese name of Cho Dai Gyoku. Murakami is being brought to Osaka to the Chinese Mission for the purpose of determining his status.

2. If he is found to be a Japanese citizen, he will be returned to Maizuru for completion of processing. If found to be a Chinese citizen, he will be sent to the Osaka Stockade for possible trial by Provost Court for illegal entry into Japan.

2. GHQ, SCAP has approved the application for repatriation to Korea of the Korean Nationals listed in attached inclosure. The number of dependents authorized for repatriation is listed opposite the head of each family in the inclosure.
3. The Korean nationals are being informed of the approval of their applications by the Japanese Government. They are also being instructed that travel to Sasebo will be at their own expense and that travel from Sasebo to Korea may be made on Shipping Control Authority Japanese Merchant Marine repatriation vessels returning illegal Korean entrants to Korea.
4. Subject repatriates must report for repatriation shipping within ninety days of the date listed on the inclosure.
5. Korean repatriates are to be permitted to convert Japanese yen for Korean won not to exceed Y100,000 per individual. Authorized accompanied baggage will not exceed 4,000 pounds per family unit to household.

2. GHQ, SCAP has approved the application for repatriation to Korea of the Korean Nationals listed in attached inclosure. The number of dependents authorized for repatriation is listed opposite the head of each family in the inclosure.

3. The Korean nationals are being informed of the approval of their applications by the Japanese Government. They are also being instructed that travel to Sasebo will be at their own expense and that travel from Sasebo to Korea may be made on Shipping Control Authority Japanese Merchant Marine repatriation vessels returning illegal Korean entrants to Korea.

4. Subject repatriates must report for repatriation shipping within ninety days of the date listed on the inclosure.

5. Korean repatriates are to be permitted to convert Japanese yen for Korean won not to exceed ¥1,000 per individual. Authorized accompanied baggage will not exceed 4,000 pounds per family unit of household items.

6. It is desired that routine supervision and surveillance be given this repatriation.
