FY 1987 Budget Resolution

Prior to adjourning for the July 4 recess, the Congress passed a budget resolution for FY 1987. This resolution is a non-binding guide for tax and spending decisions to be used as a framework by Congress as it continues its budget process. The resolution meets the \$144 billion deficit target set by last year's Gramm-Rudman-Hollings legislation.

According to our sources, the approved resolution provides for the current funding level of \$328 million for the Extension Service be maintained in FY 1987. Final appropriated levels are, of course, determined by the House and Senate Appropriation Committees. We will keep you informed of further developments.

1) Bird Quarantine Facilities

The Animal and Plant Health Inspection Service (APHIS) proposes to amend regulations concerning the importation of birds into the U.S. They are extending the time period allowed for certain applicants selected for consideration for approval of privately-operated bird quarantine facilities in Miami, Florida. 
Applied Agricultural Research
